AN ACT

RATIFYING AND AFFIRMING A CONVEYANCE BY THE CITY
OF PROVIDENCE

It is enacted by the General Assembly as follows:

SECTION 1. The sale and conveyance by the City of Providence to Samuel G. Fora and Edward R. Fora, a partnership doing business as Sage Manufacturing Company of Providence of real estate on the easterly side of Mill Street, in the City of Providence, by deed dated and acknowledged May 26, 1954 and recorded in Deed Book 1023 at page 446, of the City of Providence Land Records, is hereby ratified and affirmed.
