




After reviewing the docket for the City Council meeting of October 21, 1976, I noted that item number 11 calls for the passage of a resolution requesting the investigation of the funding of the Mayor's Office of Community Development and its expenditures to date.

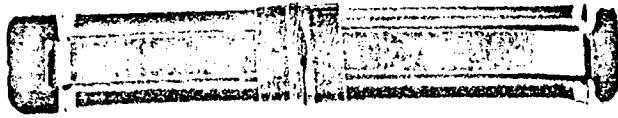
