I hereby submit the annual report of the operations of
the Probate Court of the City of Providence for the fiscal
year beginning July 1, 1989 and ending June 30, 1990.

The cash receipts for this period amounted to \$171,083.73,
which was up from \$134,478.40 for the previous period.

In the period from July 1, 1990 to December 31, 1990 the
collections totaled \$81,807.43, which was up from \$74,841.66.

If the receipts continue as in the past I would anticipate
that the receipts for the fiscal year ending June 30, 1991 to
be around \$160,000.

The number of wills filed for probate this past year was
271 compared to 281 from last year, and the number of petitions
for administration was 90 as compared to 112 for the previous year.

The number of guardianships granted by the court was 84
as opposed to 77 for last year. There were 5 new petitions for
conservatorship granted during this period. There was one
adult adoption granted during this period.

There were 123 change of name petitions granted this period
as against 121 during the same period for the previous year.
In addition thereto there were 28 petitions for sale of real
estate filed by various executors, guardians and administrators.
There were also 262 miscellaneous petitions filed and granted for
various reasons.

There were 401 inventories filed by the fiduciaries and the
necessary fees collected and reflected in the total receipts of
the year.

During the year there were 239 accounts filed and processed, by guardians, conservators, executors and administrators. There were 216 affidavits of completed administration.

There were six new registry accounts opened for absentees totaling \$15,408.98, and one for a minor in the amount of \$10,255.39.

All of these accounts, sales, affidavits and other petitions were processed by the staff of the court, advertised when necessary, and the necessary action taken by the court during this period.

Any matters pending before the court are pending, not by reason of any delay of the court, but by failure to assign to hearing by the attorneys involved.

Although I am seriously understaffed I am fortunate in that the personnel I do have are extremely loyal and capable and permit this office to operate as efficiently as possible under the circumstances.
