That His Honor the Mayor is hereby authorized to accept a license from the United States of America to use and occupy land of the Veterans Administration at the Veterans Administration Hospital in Providence, as a play field upon certain conditions to be agreed upon between his Honor the Mayor and the Veterans Administration, substantially in accordance with the terms and conditions set forth in the accompanying draft license; the area subject to license being indicated on the plan marked, Providence, R.I., City Engineer's Office, City Property Dep't., February 16, 1945, No. 059448 by the letters a-b-c-d-e-f-g-h-O-P-Q-R-a on said plan.

RESOLUTION AUTHORIZING THE
MAYOR TO ACCEPT A LICENSE
FROM THE UNITED STATES OF
AMERICA TO USE AND OCCUPY
LAND OF THE VETERANS
ADMINISTRATION AT THE VETERANS
ADMINISTRATION HOSPITAL IN
PROVIDENCE, AS A PLAY FIELD,
UPON CERTAIN CONDITIONS
IMPOSED BY THE VETERANS
ADMINISTRATION, SUBSTANTIALLY
IN ACCORDANCE WITH A PROPOSED
LICENSE

LICENSE

THE UNITED STATES OF AMERICA, represented by the VETERANS ADMINISTRATION, hereinafter referred to as the Government, hereby grants a License to the City of Providence, a municipal corporation of the State of Rhode Island, hereinafter referred to as the Licensee, to use and occupy the following described land of the Government at the Veterans Administration Hospital, Providence, Rhode Island:

Commencing at the southeastern corner of the Veterans Administration Hospital reservation, Providence, Rhode Island, thence westerly along the southern boundary of said reservation 100 feet to a point; thence deviating to the right at an internal angle of $90^{\circ}15'25''$ 100 feet to a point; thence deviating to the left at an internal angle of $90^{\circ}16'$ a distance of 129.08 feet to a point; thence deviating to the right at an internal angle of $116^{\circ}30'$, 134.10 feet to a point; thence deviating to the left at an internal angle of $114^{\circ}28'$, a distance of 127.7 feet to a point; thence deviating to the right at an internal angle of $113^{\circ}43'$, 214.22 feet to a point; thence deviating to the left at an internal angle of $168^{\circ}27'45''$, a distance of 189.26 feet to a point; thence deviating to the right at an internal angle of $163^{\circ}33'$, 114.13 feet to a point; thence deviating to the right at an internal angle of $161^{\circ}02'$, 626.16 feet to a point on the northern boundary of the hospital reservation, thence easterly along the northern boundary to the northeast corner of said reservation and thence in a southerly direction along the easterly boundary and the point of beginning, all as indicated on the Building Number and Location Plan dated July 1, 1949, attached hereto marked Exhibit "A" and incorporated herein as a part of this License.

This License is granted upon the following terms and conditions:

1. Use and occupancy of the premises shall be without cost or expense to the Government, under the general supervision and subject to the approval of the Manager, Veterans Administration Hospital, Providence, Rhode Island, who shall administer the conditions of this License, and subject also to such further rules and regulations as he may from time to time prescribe.
2. This License shall be effective from the date of acceptance by the Licensee and is revocable at will by the Government.
3. The Licensee hereby agrees to install and maintain an underground culvert as indicated on the attached Building Number and Location Plan.
4. The Licensee will make available to the patients of the Veterans Administration Hospital, under the Physical Medicine Rehabilitation Program, the recreational facilities planned by the City in this area.
5. The Licensee will enclose this area with suitable hedging for screening and protection, and suitably landscape the area with a buckthorn hedge enclosing it along the street lines.
6. That supervision will be provided by the Licensee for all recreational activities conducted in the area.
7. That no permanent structures will be erected in the area without the prior approval of the Veterans Administration.
8. The terms and conditions of the License dated May 1, 1947, from the Veterans Administration to the City of Providence, Rhode Island, are modified hereby insofar as the area described therein is included in the area covered by this grant.

9. Licensee shall make adequate provisions to prevent trespass by its agents, employees and invitees to other lands of the Government reservation.
10. Licensee shall indemnify and save the Government harmless from any liability or responsibility of any nature whatsoever arising directly or indirectly from the privileges herein granted.
11. Upon revocation or termination of this License, the Licensee at its sole expense shall remove its property and within a reasonable time, restore the premises to substantially the same condition as that existing at the time of entry hereunder, damages by the elements and from causes beyond the control of the Licensee excepted.
