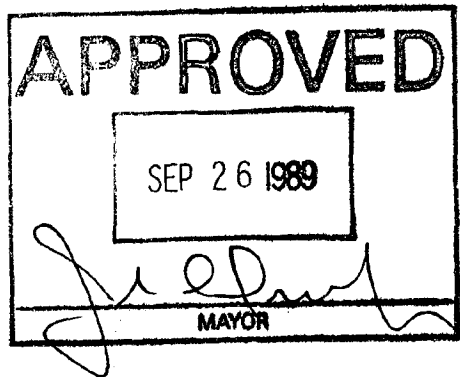


Dear Mr. President and Council Members:

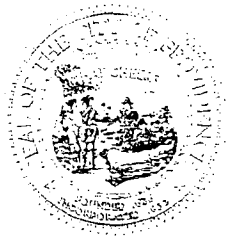



TEACHER RECRUITMENT EFFORT

At the end of March, the Providence School Department hired a full-time Teacher-Recruiter, Lynne Edmonds.

She in concert with Joyce O'Connor, the Affirmative Action Officer, began to tackle the problem of anticipated teacher vacancies that would result from retirements and enforcement of the residency rule of the Providence City Charter.

It was decided that a full-fledged effort would involve advertising locally, regionally and nationally, meeting with community agencies and contacting representatives of colleges and universities at their respective institutions and by way of conferences and job fairs.

The attached outlines the recruitment effort to date and also includes samples of advertisements that have been placed in various media. A brochure designed for mass mailings and wide distribution to individuals at conferences and job fairs, etc., is also included.

Our search has been extensive. We have concentrated our efforts in areas of the country that have strong Education Departments--particularly in Reading, Special Education, Library Science and Bilingual Programs.

The multiethnic diversity within a city was crucial when deciding upon out-of-state newspapers and selecting teacher placement agencies. We discovered that difficult-to-fill vacancies were not a unique problem to Providence. School departments such as Boston that are undergoing cutbacks are not laying off teachers in these difficult-to-fill areas.

The advertisements that are not enclosed have not been received by this office as of August 4, 1989. Also, many colleges and universities have preferred to respond to mailings via telephone.

WHEREAS, Certain vacancies in teaching positions have occurred as a result of the implementation of the Home Rule Charter of the City of Providence, Section 1210; and

WHEREAS, Concerted recruiting efforts have taken place from March 1989 to the present in an attempt to fill these vacancies; and

WHEREAS, A diligent search has determined that there are no qualified and certified applicants that are domiciled in the City of Providence or willing to sign an agreement that they shall become residents of the City within six months of appointments; and

WHEREAS, It is essential that the teaching positions be filled;

NOW, THEREFORE, BE IT RESOLVED, That the Superintendent be authorized to request that the Mayor certify that after a diligent search no persons with proper qualifications can be found among residents of the City and that the City Council exempt the following teachers from the provisions of Section 1210 of the Providence Home Rule Charter.

Regulations require that all individuals certified for the first time in Rhode Island after December 1, 1986 must successfully pass the core Battery of the National Teachers' Examination. Contact: Rhode Island College (401) 456-8000 for information.

New Immigration Law:

The Immigration Control Reform Act of 1986 now states that in order to be employed you must produce copies of the following:

- Social Security Card or Birth Certificate
- A State's Driver's License or I.D. Card with a photograph or information including name, sex, date of birth, height, weight, and eye color.

Credit for Prior Experience:

Upon being appointed, salary adjustments will only be made upon receiving all of your transcripts and verification of your prior full-time teaching experience. You should be sure we know the names and full address of all your former employers.

Out of State Applicants:

Interstate Certification Compact (Reciprocity)

In addition to all of the above, experienced teachers seeking certification under ICC must submit a copy of their certificate from the originating state and an official statement from their superintendent of schools verifying at least 27 months of experience within the last 7 years from the date of application.

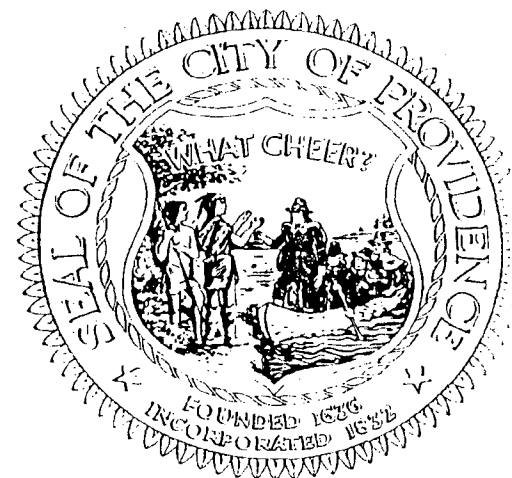

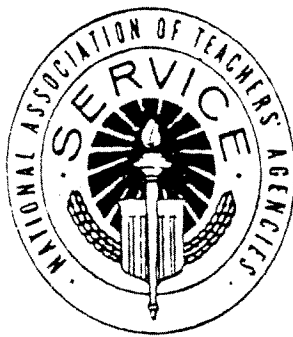


