Resolution Authorizing the Mayor and Chairman of the Water Supply Board to Execute a Contract with the State of Rhode Island in Connection with Rearrangement and Reconstruction of Portions of the Water System in the Area of Atwells Avenue, Knight Street and the Route 6 Connector.

*Whereas*, The State of Rhode Island is planning the reconstruction of a section of Atwells Avenue, Knight Street and the construction of a portion of the Route 6 Connector roadbed and a new bridge over the roadbed and the tracks of the Penn Central Transportation Company, in the City of Providence, with funds apportioned to the State under the Federal-Aid Highway Act, as

amended and supplemented, and from other sources available for the purpose, and

*Whereas*, In connection with said construction and reconstruction of said highway and appurtenances it will be necessary to disrupt, displace, rearrange and reconstruct portions of the existing water system of the City of Providence, and

*Whereas*, The Relocation and adjustments of the City of Providence's facilities must be closely and dependably integrated with the reconstruction of said highway and appurtenances during the various phases of operations for the best interests of traffic movement and control and public convenience, and

*Whereas*, The City of Providence desires to co-operate with the State of Rhode Island.

*Now, Therefore, Be It Resolved*, That the Mayor of the City of Providence and the Chairman of the Water Supply Board of the City of Providence be, and they hereby are, authorized to execute for and in behalf of the City of Providence with the State of Rhode Island a contract, substantially in the form of the contract hereto attached and made a part hereof by reference, providing for the rearrangement and reconstruction of portions of the existing water system of the City of Providence in the area of Atwells Avenue, Knight Street and the Route 6 Connector, Atwells Avenue Bridge, at no cost to the City of Providence.
