VIZ:

HILLCREST AVENUE, (portions of), shown as cross-hatched area on accompanying plan and designated by the letters (A-B-C-D-A) having ceased to be useful to the public and is proposed to be abandoned as a Public Highway. Said Abandonment is specifically conditioned precedent upon the following: (1) Petitioner shall tender the amount of Nine Thousand Eight-Hundred Dollars (\$9,800.00) in legal tender U.S. to the City of Providence. And it is further

ORDERED, That the Traffic Engineer be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway." And it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.


Subject: Request for Abandonment of Certain City Streets

Sir: Attached is a request for review of "request for portions of Hillcrest Avenue and Atkins Street to be abandoned". Attached you will also find photographs of the areas in question. Listed below are the results of the review:

1. Atkins Street: There is no real problem with the partial abandonment of the street, but there is one (1) lot which when the street is closed, the owner(s) will have no access to the lot. The lot in question is #546. I have no idea who owns the lot, nor do I have any knowledge if Atkins Street is, or has ever been used as access to same, but I feel it should be addressed.

2. Hillcrest Avenue: The area in question could be "just" the corner, but the street does not exist from Ridgeway Avenue thru to Ruby Avenue. For all purposes, Hillcrest Avenue ends at Ada Street at Ridgeway Avenue. There is a strip on paper which is Hillcrest Avenue, but it is filled with trees, and very large rocks. I do see any police problem with the abandonment.
