Be it ordained by the City of Providence:

SECTION 1. Chapter 1288 of the Ordinances of the City of Providence as approved September 18, 1959, entitled: "An Ordinance Making Appropriation of \$39,301,585.32 for the Support of the City Government for the Fiscal Year Ending September 30, 1960", as amended, is hereby further amended by adding the following sums to the LAW DEPARTMENT appropriation, ITEM 1-\$700; ITEM 2-\$250 and ITEM 5-\$500.

SECTION 2. The said sum of Fourteen Hundred Fifty (\$1,450) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures to the Receipt Account.

SECTION 3. The estimated receipts from Reserve for Extraordinary Expenditures are hereby increased by Fourteen Hundred Fifty (\$1,450) Dollars.

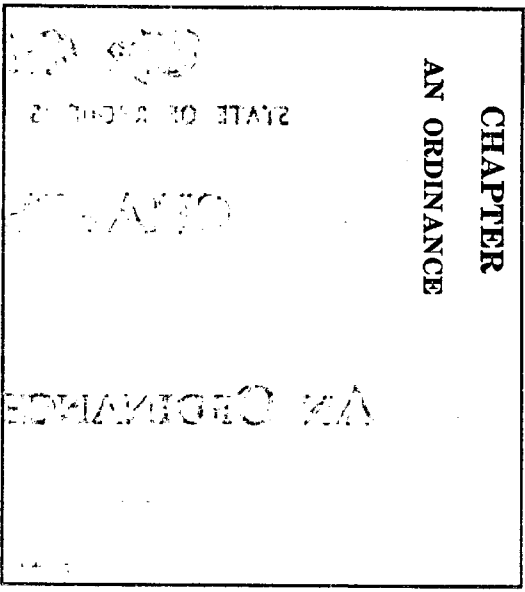

SECTION, ITEM 7.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1288 of the Ordinances of the City of Providence as approved September 18, 1959, entitled: "An Ordinance Making Appropriation of \$39,301,585.32 for the Support of the City Government for the Fiscal Year Ending September 30, 1960", as amended, is hereby further amended by appropriating the sum of One Hundred Twenty Five Thousand (\$125,000) Dollars to PUBLIC WORKS-SEWAGE DISPOSAL SECTION, ITEM 7.

SECTION 2. The said sum of One Hundred Twenty Five Thousand (\$125,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated receipts from Reserve for Extraordinary Expenditures are hereby increased by One Hundred Twenty Five Thousand (\$125,000) Dollars.

SECTION 4. The City Controller and the City Treasurer are hereby authorized and directed to pay over this appropriation from the General Fund to the account in the Capital Funds known as "SEWAGE TREATMENT ACCOUNT #3". Any unexpended balance remaining in this account upon completion of this work shall revert to the General Fund.

SECTION 5. This Ordinance shall take effect upon its passage.

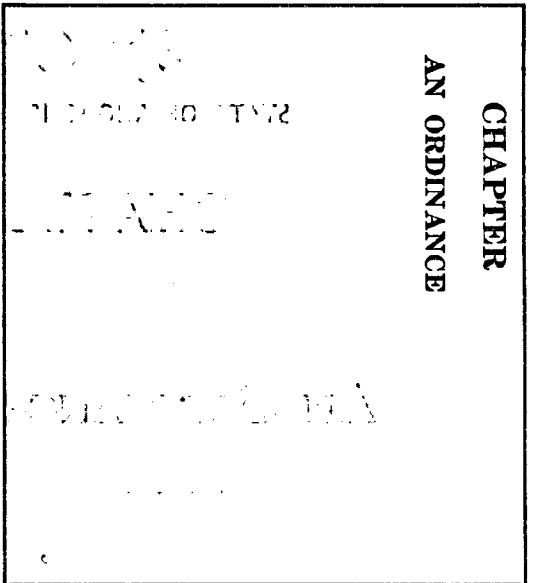
