In the Providence Board of Licenses' 2018 Annual Report to the Providence City Council, as Chairman, on behalf of the Board, I outlined our plans and responses to both the Pine Report and the Blum Shapiro Audit. At this juncture, the Board of Licenses ("Board"), in concert with the Licensing Department Staff and Director Kilkenny, has made great strides in all aspects of the recommendations made in both the Report and Audit. This success has allowed the Board to return to a more "business as usual" approach to both our day to day work as well as this Annual Report. In the vein, and in the interests of brevity, this year's report will focus solely on Providence City Code §14-316. Accordingly, the Board responds to each of the PVD Code §14-336 Subsections as follows:

5. Policy Changes

- a. Throughout the past year, and as noted in the 2018 Annual Report, the Board has identified and altered many imperfect policies. That said, for the most part, those policy amendments dealt with our most severe concerns, as highlighted in previous reports, as well as the low hanging fruit. This is good news and bad news. While the Board has already dealt with many concerns, the concerns that remain are more detailed and complex than may be readily addressed in brief meetings.
- b. Therefore, I am seeking to replace one (1) of our three (3) public hearings per week with public workshops on policy concerns or an occasional staff meeting where I will help in the more detailed drafting and coordination concerns of some of these more complex issues.
 - i. Some of the more complex issues I would hope to discuss and address at these public workshops include:
 - 1. Planning and Zoning Department's role
 - 2. Licensing enforcement and prosecution procedures
 - a. Show Cause Calendaring
 - b. Prehearing Calendaring
 - 3. Unnecessary burdens on the business community
 - a. Specifically, I do not understand the value of reviewing an entertainment application in a commercial zone if and when the entertainment cannot be heard outside of the building.
 - b. Moreover, I believe the Creative Capital has become unduly burdensome on entertainment as a whole as a result of some acute entertainment issues. Our recent successes in dealing with acute entertainment problems provides us with an opportunity to be rebalance our approach and facilitate entertainment that does not cause nuisances.
 - ii. Late Night Entertainment
 - 1. Soft Closings
 - iii. Administrative Procedure and Authority
 - 1. Empowering the Director to set administrative procedures
 - 2. Empowering staff to administratively approve minor applications when there is no public hearing requirement and no objection from the City or the Licensing Enforcement Unit
 - iv. Neighborhood Meetings
 - 1. Community Engagement on a more direct but less rigid level
 - v. After Hours License
 - 1. Ordinance to address the 4am – 6am gap in present permitting
 - vi. Stalled Approvals
 - 1. Follow up policy for new licenses or transfers that are not timely completed
