COUNCILMAN ALLEN requests the privilege of the floor to speak on a point of personal expression and states:

"I refer to the Gilbert Stuart Elementary School and the fact that although the Providence School System opened that the young men and women of the Eighth Ward and the surrounding wards will not be able to attend school. That kind of upset me because I don't understand why these contractors had all summer, three months, to complete whatever work they had been assigned to do and they couldn't get it done all summer, but by extending the vacation by one day, they could get the work done. It seems to me somebody dropped the ball here. Whether it was the Providence School Department, whether it was the Purchasing Department, or whether it was the contractors themselves, somebody didn't take this serious and as a result of that the kids didn't get to school today. As a result of this I went today over to the Leviton Complex which is across the street from Gilbert Stuart, our two new schools, and what I found there was even equally distressing, because in fact, I don't think those schools should have opened. We

found plywood in the classrooms, we found computers were not installed or not put up, we found open ventilation ducts because of the ventilation problem that the school seems to have, as well as many of the schools across the city. My point, Madam President and Honorable Members of this body, is that somebody needs to be serious about providing, renovated and adequate schools for our kids. I am going to ask that the Purchasing person, Mr. Sepe, from now on when he gives out contracts for school work, and maybe for all contracts, that there should be a "drop dead" clause in it, and in fact if people do not do the work in a timely fashion that there be some kind of punitive or some kind of financial penalties. I think that is the only way these contractors who are getting sometimes six digit, or seven digit figure contracts, make sure that they get the work done and get it done in a timely fashion. So Madam President I would hope that this message gets sent out to the appropriate persons and they be a little more attentive in terms of doing what they get paid to do, and that this is ensuring that our children get a sound education".
