Mr. Walsh will fill the expired term of Dean Holt who has resigned.







Mr. Fox will fill the expired term of Carol Grant who has resigned.





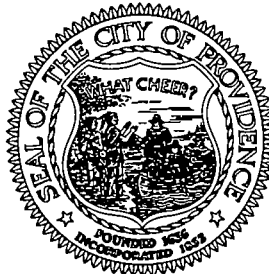
