WHEREAS, Council President Peter S. Mancini has, pursuant to Section 406 of the Providence Home Rule Charter of 1980, requesting the City Clerk, in writing, to Call a Special Meeting of the City Council to be held on Thursday, July 15, 2010 upon the rise of the Regular Meeting of the City Council in the City Council Chamber, Third Floor, City Hall for the purpose of Enacting the following:

Consideration of Mayor David N. Cicilline's **VETO** of the Ordinance Entitled: "An Ordinance in Amendment of Section 21, Article II (Section 21-26, by Adding Subsection (2), As Amended", approved by the City Council at its meeting held July 1, 2010.

An Ordinance Amending Article 1 of Chapter 15 of the Code of Ordinances, Entitled: "Motor Vehicles and Traffic."

Resolution Requesting the placement of the following 2010 Ballot Questions to amend Section 1007, 401(d) and 412 of the Providence Home Rule Charter:

*Shall the Board of Contract and Supply membership be changed by removing the director of public works, the commissioner of public safety, the chairperson of the water supply board, and the president of the school committee as members and adding as a member the chairperson of committee of the city council with jurisdiction over public works, and allow board members who serve on the city council to designate other council members to serve on the board in their absence? [Amends Section 1007]*

*Shall acts that by Charter require approval of two-thirds of the city council be exempt from mayoral veto? [Amends Section 401 (d) and Section 412].*

You are therefore, hereby commanded and required to summon each Member of the City Council to that Special Meeting, as Called.

HEREOF, Fail Not, and make a true return of this Warrant, with your doings thereon.


