COUNCILWOMAN YOUNG Requests the privilege of the floor to speak on a Point of Personal Expression and states:

I wasn't going to say it but I just don't want the record to be without my voice in saying something about the snow storm. It really wasn't done that well in the 11th Ward, you need to know that and I don't want anyone to get the impression that I'm satisfied and my constituents are satisfied because we really weren't. I was away in Florida that day and I was the last flight out of Green Airport I believe that Saturday and I received so many calls about the streets that were not plowed adequately. One of the major problems it seemed to me was that you had all these small plow trucks making one pass and not doing a second pass so curb to curb didn't exist in my ward at all. You had problems on the corners, the intersections. You had major problems with automobiles that should have been towed that the police were not towing. Communications was not informing them of the problems so you had three and four houses in a row that people could not get out of their driveways because of the parked cars that were covered with snow up until I guess around Tuesday. So even though I was on vacation in Florida I had to continually call back here to this staff about all the problems that we were having on certain streets particularly with the snow plowing so I think we need to look at it. If you're going to have

those little trucks you need to make sure that the big ones accompany them and you need to do curb to curb. If you ride around my neighborhood today you'll still see remnants of this snow storm and it was two feet of snow. I'm not sure who my supervisor was because I know the President asked the week before about giving that list out to us and I never received a list of who my supervisor was so I would have called that person personally but I will find that out for the next storm but I just want you to know that this was still a real disappointment. Granted it was a lot of snow, the Governor declared a State of Emergency so there was ample opportunity to clear the snow if people stayed off the streets but you have to do better. It might have been good for some communities and I think, you got special attention councilman because they were probably ignoring my neighborhood but we really did not get a good job done in the 11th Ward and I really think we need to call those who are doing it into accountability for not getting this done the right way. This state, we're not new comers to snow and I think we should by now be able to handle snow removal. I'm not sure when we're going to get it right but this still is unacceptable and I just want to be on the record saying that, that we're still disappointed. The next snow storm I will expect my community to be done a lot better than what it was done this passed snow storm. Thank you Mr. President.

COUNCILMAN MANCINI Requests the privilege of the floor to speak on a Point of Personal Expression and states:

I want to first of all commend the Council President on his quick response and his immediate response to the editorial that was in the Journal regarding Council Members co-paying for their medical benefits. If you read the editorial it made it sound like we didn't even think about it when in fact we already agreed that we were willing to pay and we were going to pay and it was initiated by our President and we all agreed to doing it but the Journal made it sound like that they were telling us something that we don't know

or that we don't care about the taxpayers and we're not trying to help the taxpayers which we are doing. So I just want to commend you on that there and maybe the Journal if they cared more about their employees, and I recall we had to pass a resolution asking them to sit down with their employees and work out a fair contract but I don't want anybody to think that this Council doesn't care about the taxpayers because we certainly do but with the leadership of our President we are co-paying for our benefits. Thank you.

ORDINANCES SECOND READING

**The Following Ordinances were in City
Council February 3, 2005, Read and
Passed the First Time and are Severally
Returned for Passage the Second Time:**

An Ordinance of the City of Providence Approving the Issuance of Water Revenue Bonds in an amount not to exceed \$9,000,000 to refund the outstanding portion of the City's \$12,000,000 Clean Water Revenue Bonds. (Providence Water Supply Board - 1994 Series)

Be it ordained by the City of Providence:

Section 1. The City of Providence, Rhode Island (the "City") has previously issued its \$12,000,000 Clean Water Revenue Bonds (Providence Water Supply Board - 1994

Series) dated December 1, 1994 (the "Prior Bonds").

Section 2. In accordance with Sections 46-12.8-8 and 46-12.8-9 of the Rhode Island General Laws, the City Treasurer and the Mayor be and hereby are authorized to borrow" an amount not exceeding Nine Million Dollars (\$9,000,000) from the Rhode Island Clean Water Finance Agency to refund the outstanding portion of the Prior Bonds in order to take advantage of the lower interest rates which are currently prevailing, and to evidence such loan, such officers are hereby authorized to issue and refund on behalf of the City, in an amount not exceeding Nine Million Dollars (\$9,000,000) water revenue bonds (the "Bonds") of the City, at one time, or from time to time in order to meet the foregoing appropriation.

Section 3. Pursuant to Sections 46-12.8-8 and 46-12.8-9 of the Rhode Island General Laws, as amended, the City is authorized to issue the Bonds to pay all or any part of an issue of bonds then outstanding, including principal, redemption premium, if any, interest on the outstanding bonds coming due on or prior to the date on which those bonds are to be redeemed, and the cost of issuing the Bonds.

Section 4. The period of usefulness of the project being refinanced by the Bonds is expected to be not less than eleven (11) years.

Section 5. The Bonds shall be payable solely from revenues of the Providence water supply system. The manner of sale, amount, denominations, maturities, conversion or registration privileges, interest rates, medium of payment, and other terms, conditions and details of the Bonds may be fixed by the officers authorized to sign the

Bonds. The net debt of the City is not affected by the issuance of the Bonds and the Bonds authorized hereby will be within all debt and other limitations prescribed by the Constitution and the laws of Rhode Island.

Section 6. The City Treasurer, the Mayor and the General Manager and Chief Engineer of the Providence Water Supply Board are also authorized, empowered and directed, on behalf of the City, to: (i) execute, acknowledge and deliver any and all other loan agreements, documents, certificates or instruments necessary to effectuate such borrowing; (ii) amend, modify or supplement the Bonds any and all other loan agreements, documents, certificates or instruments at any time and from time to time, in such manner and for such purposes as such officers shall deem necessary, desirable or advisable; (iii) do and perform all such other acts and things deemed by such officers to be necessary, desirable or advisable with respect to any matters contemplated by this Ordinance in order to effectuate said borrowing and the intent hereof.

Section 7. The City Treasurer and the Mayor be, and hereby are, authorized to deliver the Bonds to the purchaser and said officers be, and hereby are, authorized and instructed to take all actions, on behalf of the City, necessary to ensure that interest on the Bonds will be excludable from gross income for federal income tax purposes and to refrain from all actions which would cause interest on the Bonds to become subject to federal income taxes.

Section 8. The City's Director of Finance, the Mayor and the General Manager and Chief Engineer of the Providence Water Supply Board are authorized to take all actions necessary to comply with federal tax

and securities laws including Rule 15c2-12 of the Securities and Exchange Commission (the "SEC Rule") and to execute and deliver a Continuing Disclosure Certificate in connection with the Bonds in the form as shall be deemed advisable by the City's Director of Finance and the Mayor in order to comply with the SEC Rule. The City hereby covenants and agrees that it will comply with and carry out all of the provisions of the Continuing Disclosure Certificate, as it may be amended from time to time. Notwithstanding any other provision of this ordinance or the Bonds, failure of the City or the Providence Water Supply Board to comply with the Continuing Disclosure Certificate shall not be considered an event of default; however, any Bondholder may take such action as may be necessary and appropriate, including seeking mandate or specific performance by court order, to cause the City or the Providence Water Supply Board to comply with its obligations under this Section and under the Continuing Disclosure Certificate.

Section 9. This Ordinance shall take effect upon its passage.

An Ordinance to Authorize the Issuance of Special Obligation Tax Increment Refunding Bonds of the City of Providence to Refund the Outstanding Portion of Its \$13,260,000 Special Obligation Tax Increment Bonds, Series A Dated February 15, 1995, \$10,435,000 Special Obligation Tax Increment Bonds, Series C (AMT) Dated March 8, 1995 and \$11,000,000 Special Obligation Tax Increment Bonds, Series D Dated April 1, 1996.

Be it ordained by the City of Providence:

Section 1. The City of Providence (the "City") has previously issued its \$13,260,000 Special Obligation Tax Increment Bonds, Series A dated February 15, 1995, \$10,435,000 Special Obligation Tax Increment Bonds, Series C (AMT) dated March 8, 1995, and \$ 11,000,000 Special Obligation Tax Increment Bonds, Series D dated April 1, 1996 (the "Prior Bonds").

Section 2. The City desires to issue special obligation tax increment refunding bonds (the "Refunding Bonds") to refund the Prior Bonds in order to take advantage of the lower interest rates which currently are prevailing.

Section 3. The City is authorized pursuant to Section 10 of Chapter 33.2 of Title 45 of the General Laws of Rhode Island, as amended, to issue its Refunding Bonds to pay all or any designated part of an issue of bonds then outstanding, including principal, redemption premium, if any, interest on the outstanding bonds coming due on or prior to the date on which those bonds are to be redeemed, and the cost of issuing the Refunding Bonds.

Section 4. The City has determined that refunding some or all of the outstanding Prior Bonds in order to obtain debt service savings would result in financial benefits to the City.

Section 5. It is hereby declared that the Refunding Bonds authorized hereby will be within all debt and other limitations prescribed by the Constitution and laws of the State of Rhode Island.

Section 6. The City is hereby authorized to issue its Special Obligation Tax Increment Refunding Bonds in an amount necessary to refund some or all of the outstanding Prior

Bonds and to provide for any principal, redemption premium, and interest on the outstanding Prior Bonds coming due on or prior to the date on which those Prior Bonds are to be redeemed, and the costs of issuance.

Section 7. The manner of sale, denominations, maturities, interest rates and other terms, conditions and details of the Refunding Bonds shall be determined by the City Treasurer and the Mayor.

Section 8. The City Council hereby authorizes the City Treasurer, with approval of the Mayor, to issue the Refunding Bonds for the purposes set forth herein and to take all actions as he deems necessary to effect the issuance of the Refunding Bonds. The Refunding Bonds shall be issued by the City under its corporate name and seal or a facsimile of such seal. The Refunding Bonds shall be signed by the manual or facsimile signature of the City Treasurer and the Mayor.

Section 9. The City Treasurer and the Mayor are hereby authorized to issue the Refunding Bonds and deliver them to the purchaser and, if applicable, said officers are hereby authorized and instructed to take all actions, on behalf of the City, necessary to ensure that interest on the Refunding Bonds will be excludable from gross income for federal income tax purposes and to refrain from all actions which would cause interest on the Refunding Bonds to become subject to federal income taxes.

Section 10. The proceeds arising from the sale of such Refunding Bonds, exclusive of any premium, accrued interest and costs of issuance, shall, upon the receipt be paid

immediately to the paying agent, paying agents, trustee or trustees for the Prior Bonds, and such paying agents shall hold the proceeds in trust until they are applied to pay or refund the Prior Bonds. While such proceeds are held in trust, they may be invested as permitted by applicable law.

Section 11. The City's Finance Director is authorized to execute and deliver a continuing disclosure certificate in connection with the Refunding Bonds issued by the City, in such form as shall be deemed advisable by the City's Finance Director. The City hereby covenants and agrees that it will comply with and carry out all of the provisions of the continuing disclosure certificate, as it may be amended from time to time. Notwithstanding any other provision of this Ordinance or the Refunding Bonds, failure of the City to comply with the continuing disclosure certificate shall not be considered an event of default; however, any bondholder may take such actions as may be necessary and appropriate, including seeking mandate or specific performance by court order, to cause the City to comply with its obligations under this Ordinance and under the continuing disclosure certificate.

Section 12. This Ordinance shall take effect upon its approval by the Mayor after its passage.

Section 3. The above paygrades and rates do not include additional compensation for employees who may be requested to work a non-standard work week or have met the CDL requirements as per the Bargaining Unit Agreement.

Section 4. The above pay grades do not include additional compensation for Supervisors who are eligible and may receive on-call pay.

Section 5. Effective with the adoption of this Ordinance, Officers, and Employees of the City of Providence may authorize Employees

to perform duties of a higher rated classification, cause by leave or retirement, and that said position is funded and provided for in this Ordinance. Said assignment may be performed for a maximum of 30 days per fiscal year. There were two articles, one on the front page of the newspaper and then one following up on the sports page of the newspaper and I just have to rise because I have to speak for the young men and the coaches at Central High School because Moses Brown or people at Moses Brown have gone to court to try to strip them of the Super Bowl Championship that they won by following the rules. Anyone who's been involved in high school sports knows out of high school you have four years to do four years. It's not like college where you have a red shirt year or if you get injured you have another year. There is a process and a procedure to be followed. If you feel that you are entitled to another year, you apply to the Interscholastic for a waiver then the Interscholastic League decides if they grant you as an individual that waiver or not. That has happened before with other athletes but if you don't apply for that waiver and then you participate in the fifth year you basically have forfeited your games that you have won that you have participated in. I think it's disturbing that people who live a privileged life and can send their children to private

schools feel that rules do not apply to them and that their argument is you didn't catch me soon enough so I can keep the championship. You know you did wrong, someone must admit the mistake and really the mistake lies in the Athletic Director. The Athletic Director should know when their students enter school and when their students exit school. It has no bearing on the young man or anyone who got caught up in the rule. Our children from Central High School and the hard work that their coaches put in should not be overlooked and should not be screwed just because someone feels they have the right to sue the Interscholastic League for an oversight from someone in their school. Again, it's disturbing to me that the Journal would write about it and basically support the position of Moses Brown if you read Bill Reynolds article, they basically support position. Private schools can pick and choose where they compete in the Interscholastic League. Moses Brown can compete in football and hockey but then decide not to compete in the Interscholastic League in basketball or track. The young men and women at Classical, Central, Mount Pleasant and Hope don't have that same choice. Rules are rules, rules are to be followed. If you break the rules it's sad but that's what happens. Thank you.



Whereas, Fred Lippitt served his country in the Army in two wars, during World War II in the Philippines and Italy, earning the Bronze Star and Purple Heart, and during the Korean War, retiring as a Lieutenant Colonel and the commanding officer of Rhode Island National Guard 103rd Field Artillery; and

Whereas, He rose to the top of his chosen field of law, serving twice as a head of his firm's executive committee, and also served on the board of some of Rhode Island's, largest institutions, including the Gorham Company, Rhode Island Trust National Bank, and the Rhode Island Hospital; and

Whereas, Fred Lippitt served 22 years in the Rhode Island House of Representatives, 10 of them as Minority Leader, where he championed a more effective and transparent state government, improved medical care for the elderly, and greater access to affordable housing for all Rhode Islander's; and

Whereas, His unswerving belief in the transformative power of education led him to become the Head of the Rhode Island Board of Regents for Elementary and Secondary Education, and Chairman of the Board of St. Marks School, Southboro, Massachusetts and Senior Fellow of Brown University, which awarded him an honorary degree and the President's Medal, and to serve on the Board of Directors for the Rhode Island School of Design and the Annenberg Institute for School Reform; and

Whereas, His devotion to bettering the lives of less fortunate Providence and Rhode Island residents included support of the John E. Fogarty Foundation for the Mentally

Retarded, the Boys and Girls Club of Providence and the Southside Community Land Trust; and

Whereas, Fred Lippitt was also a leading steward of the natural treasurers in Providence and Rhode Island, serving on the Board of Directors of the Nature Conservancy, the Trust for Public Lands, and leading the effort to raise funds to restore the Woonasquatucket River and Greenway; and

Whereas, Fred Lippitt was a three time candidate for Mayor of the City of Providence and on June 2, 2005 was posthumously made Honorary Mayor of the City; and

Whereas, During his 14 year tenure as the first Chairman of the innovative Providence Plan, Fred conceived of the reclamation of the polluted Woonasquatucket River and its environs; and

Whereas, Fred Lippitt successfully led the initiative to secure private, City, State and Federal support and funding for the environmental clean-up, the creation or reclamation

of our four parks and the construction of a 5.7 mile bike path; and

Whereas, The Woonasquatucket Greenway reclamation reflects Fred Lippitt's commitment to the urban environment, education, affordable housing and Providence neighborhoods; and

Whereas, Fred Lippitt's vision of a Woonasquatucket River Greenway that provides educational and recreational opportunities, restores the river environment, stimulates economic reinvestment, and promotes affordable housing and neighborhood stabilization is well on its way to being realized.

Now, therefore, be it resolved, That the Providence City Council rename the Woonasquatucket River Greenway in Providence the "Fred Lippitt Woonasquatucket River Greenway" as a permanent tribute to the dedication and leadership of the Honorable Frederick Lippitt.
