AN ORDINANCE IN AMENDMENT OF CHAPTER 1875 OF THE ORDINANCES OF THE CITY OF PROVIDENCE AND SECTION 17-104 OF THE PROVIDENCE CITY CODE, REDUCING THE YEARS REQUIRED FOR EXTENSION OF SICK LEAVE.

Approved January 14, 1977

Be it ordained by the City of Providence:

An ordinance in amendment of Chapter 1875 of the ordinances of the City of Providence and Section 17-104 of the Providence City Code.

SECTION 1. The second section of said ordinance shall be modified to read as follows:

Provided however, any employee with at least five (5) years of continuous service who contracts a serious illness may be granted, with the approval of the Personnel Director, the Finance Director and the Mayor, a further leave not to exceed ninety (90) days in addition to his accumulated sick leave as of the date said illness occurs.

SECTION 2. This ordinance shall take effect upon its passage and shall be retroactive to July 1, 1976.
