No. 380 **AN ORDINANCE** IN AMENDMENT OF CHAPTER 564 OF THE ORDINANCES OF THE CITY OF PROVIDENCE ENTITLED " THE CITY OF PROVIDENCE ZONING ORDINANCE" APPROVED JUNE 27, 1994, AS AMENDED, BY AMENDING PROVIDENCE ZONING DISTRICT MAPS NUMBER 81 AND 120 OF THE OFFICIAL ZONING MAP BY CHANGING THE ZONING DISTRICT DESIGNATION OF CERTAIN LOTS FROM R-1, ONE FAMILY DISTRICT TO R-P, RESIDENTIAL PROFESSIONAL DISTRICT.

Be it ordained by the City of Providence:

Section 1 : Chapter 564 of the Ordinances of the City of Providence, entitled " The City of Providence Zoning Ordinance" approved June 27, 1994, as amended, is hereby amended by changing the zoning district designation of Lot 484 of the Zoning District Map Number 81 of the Official Zoning Maps from R-1, One Family District to R. P. Residential Professional District and Providence Zoning Map Number 120, Lots 12, 14, 43, 46, 84, 85, 86, 87, 440, 386, 385, 371, and 90, from R-1, One Family District to R.P., Residential Professional District.. This area is located on the northeast side of Smith Street starting at 805 Smith Street and ending at Tyndall Ave., going on lot in depth

Section 2 : This Ordinance shall take effect upon passage.
