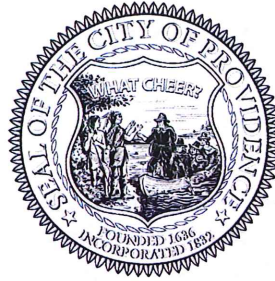

ORDINANCE(S) SECOND READING

The Following Ordinances were in City Council June 7, 2018, Read and Passed the First Time and are Severally Returned for Passage the Second Time:

COUNCIL PRESIDENT SALVATORE, (By Request):

An Ordinance in Amendment of Chapter 27 of the Code of Ordinances of the City of Providence Entitled "The City of Providence Zoning Ordinance," Approved November 24, 2014, as Amended, to Change Regulations Pertaining to Exterior Insulating Finish Systems.

SECTION 1. Chapter 27, Article 5 of the City Ordinances entitled "Commercial Districts" is hereby amended as follows:

503 DESIGN STANDARDS

A. C-1 and C-2 District Design Standards

5. Building Materials

a. The following building materials are prohibited on any façade:

i. Plain concrete block

ii. Glass block

iii. Exposed aggregate (rough finish) concrete wall panels

~~**iv.** Exterior insulating finish systems (EIFS) is prohibited on first-story façades~~

iv. T-111 composite plywood siding

vi. Plastic

vii. Vinyl (excluding cellular vinyl trim) is prohibited on first-story façades

b. The following building materials are prohibited on any façade; however, such materials may be used as decorative or detail elements for up to 25% of the façade.

i. Corrugated metal

ii. Cellular vinyl trim

- c. Exterior insulating finish systems (EIFS) is permitted on the ground floor by waiver from the City Plan Commission. An application for waiver under this subsection shall be approved provided that the following conditions are satisfied:
 - i. Only EIFS that include an integral air and moisture barrier is permitted.
 - ii. So that it is impact resistant, for areas up to 8 feet above grade, the EIFS shall include a base mesh layer weighing a minimum 20 oz./sq. yd., followed by a second mesh layer weighing a minimum of 4 oz./sq. yd. For all areas exposed to direct impact higher than 8 feet above grade (such as balconies), the use of a single layer of reinforcing mesh with a minimum weight of 12 oz./sq. yd. is required.
 - iii. The material shall be an aesthetically-appropriate facsimile of stone, brick, stucco, metal panel, or other traditional building material.
 - iv. Removal or covering of historic features in order to install EIFS shall be prohibited.

B. C-3 District Design Standards

So that it is impact resistant, for areas up to 8 feet above grade, the EIFS shall include a base mesh layer weighing a minimum 20 oz./sq. yd., followed by a second mesh layer weighing a minimum of 4 oz./sq. yd. For all areas exposed to direct impact higher than 8 feet above grade (such as balconies), the use of a single layer of reinforcing mesh with a minimum weight of 12 oz./sq. yd. is required.

iii. The material shall be an aesthetically-appropriate facsimile of stone, brick, stucco, metal panel, or other traditional building material.

iv. Removal or covering of historic features in order to install EIFS shall be prohibited.

SECTION 2. Chapter 27, Article 6 of the City Ordinances entitled “Downtown District” is hereby amended as follows:

606 DESIGN STANDARDS FOR NEW CONSTRUCTION

B. Building Materials

1. The primary exterior finish materials on the facade shall be brick, limestone, sandstone, granite, terra cotta, cast stone, glass, metal, painted wood, cement-based composites, phenolic resin-based composites, or other similar material.

2. The use of non-durable materials such as ~~exterior insulated finishing systems (EIFS)~~, vinyl, and other similar products is prohibited on the first floor and discouraged on upper floors.

3. Exterior insulating finish systems (EIFS) is permitted on the ground floor by waiver from the Downtown Design Review Committee. An application for waiver under this subsection shall be approved provided that the following conditions are satisfied:

- a. Only EIFS that include an integral air and moisture barrier is permitted.
- b. So that it is impact resistant, for areas up to 8 feet above grade, the EIFS shall include a base mesh layer weighing a minimum 20 oz./sq. yd., followed by a second mesh layer weighing a minimum of 4 oz./sq. yd. For all areas exposed to direct impact higher than 8 feet above grade (such as balconies), the use of a single layer of reinforcing mesh with a minimum weight of 12 oz./sq. yd. is required.
- c. The material shall be an aesthetically-appropriate facsimile of stone, brick, stucco, metal panel, or other traditional building material.
- d. Removal or covering of historic features in order to install EIFS shall be prohibited.

SECTION 3. Chapter 27, Article 9 of the City Ordinances entitled “Waterfront Districts” is hereby amended as follows:

SECTION 4. Chapter 27, Article 11 of the City Ordinances entitled “Waterfront Districts” is hereby amended as follows:

D. Design Standards

1. Façade Design

The primary exterior finish materials on the façade shall be brick, limestone, sandstone, granite, terra cotta, cast stone, glass, metal, painted wood, cement-based composites, phenolic resin-based composites, or other similar material. The use of non-durable materials such as ~~exterior insulated finishing systems (EIFS)~~, vinyl, and other similar products is prohibited on the first floor and is discouraged on upper floors.

g. Exterior insulating finish systems (EIFS) is permitted on the ground floor by waiver from the Downtown Design Review Committee. An application for waiver under this subsection shall be approved provided that the following conditions are satisfied:

i. Only EIFS that include an integral air and moisture barrier is permitted.

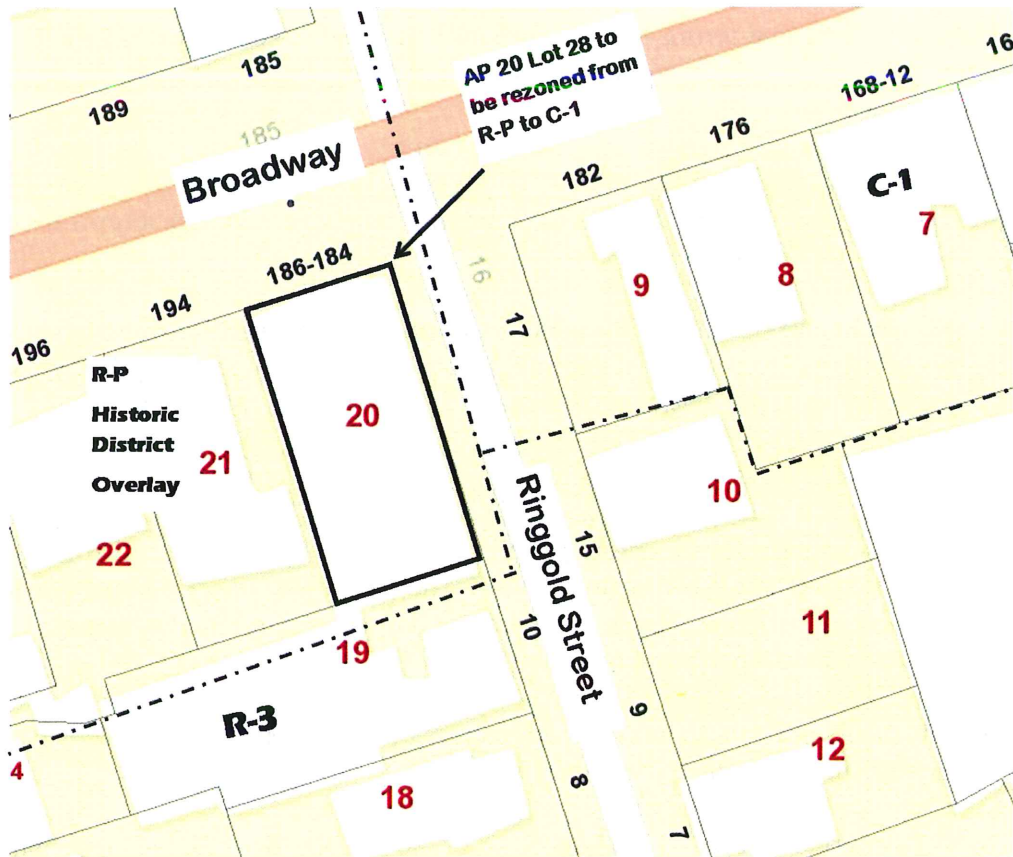

COUNCILMAN PRINCIPE

An Ordinance in Amendment of Chapter 27 of the Code of Ordinances of the City of Providence, Entitled: "The City of Providence Zoning Ordinance", Approved November 24, 2014, As Amended, to change the Official Zoning Map for AP 28, Lot 20 (184-186 Broadway) from R-P to C-1.

SECTION 1: Chapter 27 of the Code of Ordinances of the City of Providence, Entitled "The City of Providence Zoning Ordinance," Approved November 24, 2014, As Amended, is hereby further amended by changing the zoning for AP 28 Lot 20 (184-186 Broadway) from R-P to C-1, as shown on the accompanying map. The use of the lot shall be limited to a Personal Service Establishment and all other uses permitted in the R-P zone.



SECTION 2: This Ordinance shall take effect upon passage.

COUNCILWOMAN MATOS, COUNCILWOMAN CASTILLO

An Ordinance Amending Chapter 16, "Offenses and Miscellaneous Provisions," Section 27, "Failure to Pay City Fees."

SECTION 1. Chapter 16, "Offenses and Miscellaneous Provisions," Section 27, "Failure to Pay City Fees," is hereby amended as follows:

Sec. 16-27. - Failure to pay City Fees.

- (a) Any individual, organization, or other entity, except a city department, including the water supply board, (hereinafter "entity") with an outstanding balance of more than sixty (60) days after payment was due for police and fire details, or other city services shall be prohibited from obtaining any permits, licenses, licenses renewals, police details, or fire details until the balance is paid in full, and payment has been verified by the city controller.

- (b) Notwithstanding the language of subsection (a), the city controller may offer payment terms to an entity with an outstanding balance more than 60 (sixty) days past due. If the entity agrees to and accepts said terms, the prohibitions contained in subsection (a) shall not apply for as long as the entity acts in compliance with said terms. Payment terms for any such entity shall be as follows:
- (1) Payment to the city controller of 50 (fifty) percent of total balance more than 60 (sixty) days past due shall be submitted at the time the entry agrees to and accepts the payment terms.
 - a. Nonprofit corporations, charitable organizations, and small businesses shall submit twenty-five (25) percent of the total balance more than sixty (60) days past due, and the entity shall pay the balance through payment terms offered by the city controller.
 - i. "Nonprofit corporations, charitable organizations, and small business" is defined as a business that has its principal office located in Providence and employs twenty five (25) or fewer full-time employees. The location of the "principal office" is the location identified as such in the annual filings submitted by that business to the Rhode Island Department of State.
 - (2) Monthly payment installments on the remaining past due balance shall be made in an amount determined by the city controller.
 - (3) The city controller, subject to the approval of the finance director, is hereby authorized and empowered to comprise interest which may be due on all unpaid city fees that are more than thirty (30) calendar days overdue. The authority hereby vested in the city controller shall apply to interest on fees already assessed or to be assessed from time to time. Interest on unpaid city fees shall accrue at the same rate as the annually established interest rate for unpaid real estate, personal estate, and excise taxes.
 - (4) The city controller may, in his/her discretion submit the names of entities seeking forbearance on unpaid fees and interest assessed to the city council whenever doing so appears to be in the interests of the city. The city council may, at any time, review requests of entities seeking forbearance on unpaid fees and interest assessed.
 - (5) New police and/or fire detail charges must be paid in full prior to being approved such services.
 - (6) Proof of payment and compliance with payment terms shall be provided to the entity by the city controller and such documentation shall be required prior to the entity being approved for new police and/or fire detail services.
- (c) Entities that entered into and are in compliance with payment terms with the city for past due balances prior to the effective date of the ordinance from which this section derives shall not be subject to subsections (a) and (b).

SECTION 2. This Ordinance shall take effect upon passage.

COUNCILMAN NARDUCCI, (By Request):

An Ordinance Relating to Article IV, Chapter 17, Section 17-192(F) of the Code of Ordinances (Disability Waiver Request) (Lisa Scott).

SECTION 1. Notwithstanding the language of Section 17-192(f) of the Code of Ordinances which provides that the application to accomplish such [accidental disability] retirement must be filed within eighteen (18) months of the date of the accident, the Retirement Board of the City of Providence may consider and act upon the accidental disability retirement application of Lisa Scott, even though more than eighteen (18) months have passed since the date of the accident which is the averred proximate cause of the above-named applicant for a disability retirement allowance.

SECTION 2. Said application shall be subject to and considered in accordance with all other applicable ordinances, regulations, standards, and practices relating to accidental disability retirement applications.

SECTION 3. This Ordinance shall take effect upon passage.

COUNCILMAN IGLIOZZI, (By Request):

An Ordinance Relating to Article IV, Chapter 17, Section 17-192(f) of the Code of Ordinances (Disability Waiver Request)(Frank Calcione).

SECTION 1. Notwithstanding the language of Section 17-192(f) of the Code of Ordinances which provides that the application to accomplish such [accidental disability] retirement must be filed within eighteen (18) months of the date of the accident, the Retirement Board of the City of Providence may consider and act upon the accidental disability retirement application of Frank Calcione, even though more than eighteen (18) months have passed since the date of the accident which is the averred proximate cause of the above-named applicant for a disability retirement allowance.

SECTION 2. Said application shall be subject to and considered in accordance with all other applicable ordinances, regulations, standards, and practices relating to accidental disability retirement applications.

SECTION 3. This Ordinance shall take effect upon passage.

COUNCIL PRESIDENT SALVATORE

Resolution Authorizing the Mayor of the City of Providence to enter into an Escrow Agreement with the Rhode Island Department of Transportation with respect to the Tar Bridge and Hawkins Street Bridge Replacement Project.

COUNCIL PRESIDENT SALVATORE, COUNCILMAN YURDIN

Resolution Commending the Board of Licenses and Licensing Staff for Operational Improvements and Calling for the Full Implementation of the Entertainment Licensing and Nightclub Safety Report, Pine Report and BlumShapiro Review Recommendations.

WHEREAS, The Board of Licenses and the Licensing Office are vital arms of City government that play an important role in both encouraging economic growth and promoting public safety; and

WHEREAS, Since 2012, multiple independent reviews of the Board of Licenses and the Licensing Office have been conducted, including the Entertainment Licensing and Nightclub Safety Report, the Pine Report, and the BlumShapiro Performance Review resulting in many important recommendations for improving their operations, policies, and practices; and

WHEREAS, In response to the recommendations of these reports, the City Council has enacted new ordinances related to licensing, advocated for important changes to State law, and passed multiple resolutions calling for vital policy and operational reforms within the Board of Licenses and the Licensing Office; and

WHEREAS, Over the last year and a half, many of these recommendations have been fulfilled and many of the new legal obligations have been met, improving the quality of service, increasing efficiency, and modernizing many aspects of license operations; and

WHEREAS, The many advances include the adoption of a new Operations and Procedures Manual that is now available to the public online, improved recordkeeping utilizing the Open Meetings Portal and Viewpoint software, implementation of technology trainings for licensing staff, increased use of pre-hearing conferences, changes to the Board's schedule and hearing location to increase public access, and the establishment of a "consent calendar" so that routine and uncontroversial matters do not place an undue burden on the public, the Board, or licensing staff; and

WHEREAS, While these improvements are important and commendable, many outstanding issues remain and some vital recommendations are still yet to be implemented; and

WHEREAS, In the 2016 Pine Report, it was recommended that an Information Technology position be established within the Licensing Office and, in his 2018 annual report, the Chairman of the Board of Licenses referred to this position as "the greatest area of need for the Licensing Staff," and stated that "a full time technology expert dedicated solely to the Licensing Department would be an immense asset"; and

WHEREAS, However, when the Board of Licenses presented their FY2019 budget to the Finance Committee, no Information Technology position was included or requested; and

WHEREAS, In the July 2017 BlumShapiro Performance Review, it was recommended that license inspection procedures be formalized and improved to ensure the city is "completely covered and fairly inspected," yet, it is unclear if any changes have been made to inspection procedures and the FY2019 budget presented the Finance Committee proposed eliminating all but one inspector position; and

WHEREAS, Both the Pine Report and the BlumShapiro Performance Review called for more extensive training for Board members, both at the time of their appointments and throughout the course of their service, in order to ensure that Board members understand application processes, departmental functions, basic legal terms, and ethical obligations; and

WHEREAS, In response to these recommendations, in 2017 the City Council passed Sec. 14-355 of the Providence Code of Ordinances, which states that, "Any new member of the board of licenses shall be required to receive professional certified training on all relevant state statutes, city ordinances, and relevant rules and regulations, as well as ethics training and training on the board of licenses' operations and procedures manual prior to their first meeting as a member of the board"; and

WHEREAS, However, when the Board of Licenses presented their FY2019 budget to the Finance Committee, it was stated that the two most recently appointed members of the Board of Licenses had only received a "quick overview" from the License Administrator and the Legal Counsel to the Board prior to their respective first meetings and, as of this writing, neither has received ethics training; and

WHEREAS, The Entertainment Licensing and Nightclub Safety Report of 2012 called for the creation of a searchable database of historical records including "licensees, violations, dispositions of violations, et cetera": and

WHEREAS, Five years later, the BlumShapiro Performance Review found a "lack of readily available historical license/licensee information," and stated that "Board members are unable to obtain this information via a simple lookup, inquiry, and/or request of the Licensing staff"; and

WHEREAS, While Licensing staff has begun entering this information into searchable format through the City's Open Meeting Portal for each new meeting of the Board of Licenses, no historical information from meetings prior to this policy change has yet been input into this system; and

WHEREAS, After multiple reviews raised concerns about the Board of Licenses' compliance with the Open Meetings Act (OMA), the Board has implemented policies and trainings to aid in compliance, yet improvement is still needed as, on at least one occasion in recent months, an item was improperly posted on a Board of Licenses agenda in violation of OMA; and

WHEREAS, The Providence City Council has an obligation to ensure the proper management and operations of the all City agencies and departments, including the Board of Licenses and Licensing Office, and to promote open and transparent governance for the people of Providence.


