Now, Therefore, Be It Ordained by the City of Providence:

That portion of the economic development zone labeled "Number 1" attached and incorporated by reference in Chapter 1988-45 is hereby deleted in its entirety and that there is hereby established pursuant to R.I.G.L. 3-7-16.4 an economic zone labeled "Number 1" as described in Exhibit "A" and shown in Exhibit "B" which are attached hereto for the purposes of licensing Class ED Retail Alcoholic Beverages Licenses.
