

It is enacted by the General Assembly as follows:

- 1 SECTION 1. Section 45-2-15 of the General Laws in Chapter 45-2
2 entitled "General Powers" is hereby amended to read as follows:
3 45-2-15. Police officers and firefighters. -- No city or town
4 shall require that an individual reside within the city or town as a
5 condition for appointment or continued employment in its police or
6 fire department, provided, however that the provisions of this section
7 shall not apply to the city of Providence.
8 SECTION 2. This act shall take effect upon passage.
