



ORDERED, That the Traffic Engineer, be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree, the City Clerk shall cause a notice, thereof, to be published in a newspaper published in the County of Providence at least once a week for three successive weeks, and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.



DESCRIPTION OF A PARCEL OF LAND

KNOWN AS MCINTYRE COURT

Beginning at a point on the westerly line of Jefferson Street in the City of Providence. Said point being the northeasterly corner of lot Number 5 on that Plat entitled "Plat of land belonging to the I. M. Lincoln Trust Estate" filed in the City of Providence and recorded on Plat Card 925.

Thence westerly along the northern boundary of said Lot 5 and partially along Lot 4 for a distance of 152.47 feet to a point.


