


WHEREAS, James A. Glynn, former retired Captain in the Providence Police Department whose service record covered a period of forty-three years, has passed away, and

WHEREAS, Robert Francis Kennedy, late a United States Senator from the Sovereign State of New York, a former Attorney General of the United States of America, and more recently, a Democratic Candidate for the office of President of the United States of America, while campaigning for that high office was shot and subsequently succumbed from the wounds inflicted by this dastardly act, and

WHEREAS, Senator Kennedy, whose brilliant mind and exemplary moral conduct served as a guide for the multitude who joined him in his quest for that exalted office, a leader for justice for all races, an inspiration to the youth of our Nation and a symbol of that pattern which his late lamented brother, John Fitzgerald Kennedy, the thirty-fifth President of the United States of America, exemplified, and

WHEREAS, Robert F. Kennedy, sage beyond his age, whose comprehension and perceptiveness of matters domestic and foreign, projected him onto the international scene, so that he was consulted by Presidents, Prime Ministers and titular heads of governments throughout the civilized World, and

WHEREAS, Senator Kennedy, whose addresses were models and whose policy was indicative of the vigor of his youth which reflected his background and the training his devoutly religious progenitors passed on together with his spontaneous humor which was typical of his Irish ancestry, and

WHEREAS, the affluence of which he was accustomed was never worn on his sleeve, was never flouted in the presence of poverty, nor was he guilty of ever speaking down to his fellowman, but rather was more at ease when mingling with people with whom he shared a common bond, that of compassion for the plight of those less fortunate.


