





### Be it ordained by the City of Providence:

Section 1. No petition for an amendment to the zoning ordinance, including the zoning map, or for an abandonment of a public highway, shall be accepted by the Clerk of the City Council, unless accompanied by a filing fee of Twenty-five (\$25.00) Dollars, which shall be deposited with the City Clerk, and no part of which shall be returnable to the petitioner.

Sec. 2. That portion of Section 102 of Chapter 544 of the Ordinances of the City of Providence, approved September 21, 1951 and entitled, "An Ordinance Zoning the City of Providence and Establishing use, height and area regulations" insofar as said portion provides for a filing fee of Ten (\$10.00) Dollars for petitions to the City Council to amend the zoning map, is hereby repealed, and all other ordinances or parts thereof, inconsistent herewith, are hereby repealed.

Sec. 3. This Ordinance shall take effect upon its passage.





Be it ordained by the City of Providence:

SECTION 1: No person shall ride a skate board on any street, highway, sidewalk or pedestrian mall within the limits of the City.

SEC. 2: Any person or persons found guilty of violating this ordinance shall be subject to a fine of not less than ONE (\$1) DOLLAR, nor more than TWO HUNDRED (\$200) DOLLARS, or imprisonment from one to thirty days for each such offense.


