No. 135 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1984-53 APPROVED JULY 20, 1984, BY TRANSFERRING THE SUM OF FORTY THREE THOUSAND FIVE HUNDRED DOLLARS (\$43,500.00) FROM BRIDGE MAINTENANCE (1-005-09-266) TO SEWER CONSTRUCTION AND MAINTENANCE (1-005-11-269).

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1984-53 of the Ordinances of the City of Providence, as approved July 20, 1984, entitled: "An Ordinance-making an Appropriation of One Hundred Seventy-One Million, Fifty Six Thousand, One Hundred Seventy Seven Dollars and Fifty Seven Cents. (\$171,056,177.57) for the fiscal year ending June 30, 1985, as amended", is hereby further amended by transferring the sum of Forty Three Thousand Five Hundred Dollars (\$43,500.00) from Bridge Maintenance (1-005-09-266) to Sewer Construction and Maintenance (1-005-11-269).

SECTION 2. This Ordinance shall take effect upon its passage.


