**COUNCIL PRESIDENT MATOS, COUNCILMAN CORREIA,

An Ordinance in Amendment of Chapter 17 of the Code of Ordinances of the City of Providence, Entitled: "Officers and Employees", Article VI "Retirement System", "Section 17-189(A)(3) of the Code of Ordinances Entitled: "Benefits Payable".

SECTION 1: Chapter 17 of the Code of Ordinances of the City of Providence, Entitled: "Officers and Employees", Article VI "Retirement System", Section 17-189(A)(3) of the Code of Ordinances Entitled: "Benefits Payable" is hereby further amended by making the following changes, with additions underlined:

3) Each Class B member who is a member of the police department and who has attained the age of sixty-three (63) and each class B member who is a member of the police department and who attains the age of sixty-three (63), shall be retired forthwith, or on the first day of the calendar month next succeeding that in which the member shall have attained the age of sixty-three (63) years, unless said individual holds the rank of police chief, deputy police chief, or police major at the time he/she has attained, or attains the age of sixty-seven (67) years.

Each Class B member who is a member of the fire department and who has attained the age of sixty (60) and each Class B member who is a member of the fire department and who attains the age of sixty (60), shall be retired forthwith, or on the first day of the calendar month next succession that in which the member shall have attained the age of sixty (60) years, unless said Class B member of the Fire Department that holds the rank of Assistant Fire Chief of Operations and Assistant Fire Chief of Administration at the time he/she has attained, or attains, the age of sixty-three (63) years, or Class B member of the Fire Department that holds the rank of Fire Chief of Department at the time that he/she has attained, or attains, the age of sixty-seven (67) years.

SECTION 2: This ordinance shall take effect upon passage.

SECTION II. This ordinance is an affirmative action of the City Council of the City of Providence toward the issuance of the lease purchase agreement in accordance with the purposes of the laws of the State of Rhode Island. This ordinance constitutes the City's declaration of official intent pursuant to Treasury Regulation Section 1.150-2 to reimburse the City's General Fund for certain capital expenditures for the leased equipment paid on or after the date which is sixty (60) days prior to the date of this ordinance, but prior to the issuance of the lease purchase agreement. Such amounts to be reimbursed shall not exceed \$15,000,000, and shall be reimbursed not later than eighteen (18) months after (a) the date on which the expenditure is paid, or (b) the date the Project is placed in service or abandoned but in no event later than three (3) years after the date the expenditure is paid.
