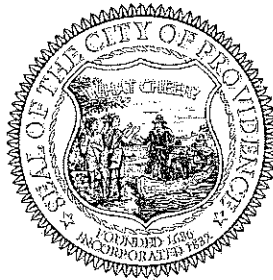


Read and Passed, on Motion of COUNCILWOMAN MATOS, Seconded by COUNCILMAN CORREIA.
