Approved November 21, 1958

Resolved, Decreed and Ordered,

That the portion of Roger Williams Avenue from Elmwood Avenue to Melrose Street which has been conveyed to the City of Providence for highway purposes by deeds acknowledged and recorded is hereby declared a public highway to be repaired at the expense of the City. A second portion of said street is hereby established as a public highway pursuant to the provisions of Chapter 1549 of the Public Laws of 1917. A third and final portion of said street is hereby declared a public highway, the same having been quietly, peaceably and actually used and improved as a public highway for the space of twenty years.
