5. Botvin Realty Company and Pepboys-Manny, Moe & Jack of Delaware, Inc., shall execute an indemnification and hold-harmless agreement approved by the Department of Law of the City of Providence.

6. Botvin Realty Company and Pepboys-Manny, Moe & Jack of Delaware, Inc., shall each supply the City of Providence with an insurance policy naming the City of Providence, its officers, employees, and agents as additional-named insures in a sum of not less than one hundred thousand dollars (\$100,000.00), which policy shall be approved by the Department of Law of the City of Providence.

7. Grantees shall not construct or affix to the realty any temporary or permanent structure other than that described to the City Council Committee on City Property.

10. Said easement shall be subject to a right of revert/right of reversion in the event that the situs of the easement is no longer utilized for the aforestated purposes.
