

Dear Mayor Cianci;

In the past twelve years ARTWORKS at the Wayne has served the City of Providence as a liason between original art, artists and local collectors. During that time we have established a reputation through the pages of the Providence Journal-Bulletin, National Trade Magazines and our clients as a reliable source of good investment quality art as well as providing a forum in which artists can display and present their work.'

It is becoming increasingly expensive to maintain a gallery of this calibre in the City of Providence under the present circumstances. The East Side is the only section of the City that can house a gallery of this type and ownership of property is the most feasible method of maintaining a ceiling on the operating costs.

Prominent members of the community, who are also our clients, agree that the most logical location for us would be the Red Bridge Gate House. The size and location of the building would be in keeping with our needs, the costs would be manageable, and the permanence of the gallery in the City would be assured. The inclusion of the gallery in the Blackstone Park area meets with the approval of those concerned with the development of that section of the City.

Providence can be proud of its social, cultural and intellectual attractions to businessmen seeking to re-locate in this City. A recent Magazine Section of the Providence Sunday Journal failed to mention art exhibition opportunities in its salute to the City because they fail to survive here. We are that exception. We have a proven ability to survive and would like to continue to serve the citizens of Providence. For the first time in twelve years we find it necessary to seek outside assistance.

We hope that you can provide that assistance in the form of lease and/or purchase of the Red Bridge Gate House or other suitable city property that may be available of the East Side. We look forward to many years of continued excellent exhibitions in the ARTWORKS Gallery and the opportunity to assist you in your goals for the community.
