RESOLUTION OF THE CITY COUNCIL

No. 592

Approved October 13, 1965

WHEREAS, NELLIE GORDON JOHNSON, late of the City of Providence, died on October 22, 1939 leaving a Last Will and Testament which provided that upon the termination of a trust created therein, a certain portion of her estate would be paid over to the Providence Playground Association, and

WHEREAS at the time of her death the said Providence Playground Association no longer existed, and

WHEREAS the Superior Court for the County of Providence by its decree entered on the 6th day of January, A. D. 1965 in that equity suit entitled "Rhode Island Hospital Trust Company vs. The Home for Aged Women", Eq. No. 31276, did direct that those amounts otherwise bequeathed to the Providence Playground Association under the terms of the aforesaid Will were to be paid over to the City of Providence and to be placed in a Fund designated as the "Nellie Gordon Johnson Playground Fund", said Fund to be used by the City of Providence exclusively for the playground program of the City of Providence, as the appropriate officers of said City shall from time to time determine, and

WHEREAS RHODE ISLAND HOSPITAL TRUST COMPANY, the present Trustee of the trust created under said Will of Nellie Gordon Johnson, is prepared to transfer to said City of Providence the sum of THREE THOUSAND ONE HUNDRED THIRTY-TWO and 99/100 (\$3,132.99) Dollars which represents that portion of the aforesaid estate which was directed to be paid over to the City of Providence in accordance with the aforesaid decree.

NOW, THEREFORE, BE IT RESOLVED,

That the City of Providence does hereby accept said sum of THREE THOUSAND ONE HUNDRED THIRTY-TWO and 99/100 (\$3,132.99) Dollars and directs the City Treasurer to receive such sum and does further hereby establish therewith a special fund to be known as the "Nellie Gordon Johnson Playground Fund". Said Fund is hereby appropriated for the use of the Department of Recreation of the City of Providence for the operation of the playground program, said sum to be expended under the direction of the Director of the Department of Recreation, and

BE IT FURTHER RESOLVED,

That the City Council does hereby record its sincere appreciation of the thoughtfulness and public spirit manifested by the late Nellie Gordon Johnson in providing said Fund.







KNOW ALL MEN BY THESE PRESENTS, That THE ALMACS CO., a Rhode Island corporation, for and in consideration of the sum of one (\$1) dollar, paid by the CITY OF PROVIDENCE, a municipal corporation created by the General Assembly of the State of Rhode Island, and located in the County of Providence therein, the receipt whereof is hereby acknowledged, has remised, released and forever quitclaimed, and by these presents does remise, release and forever quitclaim unto the said CITY OF PROVIDENCE, its successors and assigns forever, all the right, title, interest, property, claim and demand which it now has or of right ought to have, or claim in and to the following described parcels of land:

PARCEL A

That certain tract or parcel of land situated on Plainfield Street and Nancy Street in the City and County of Providence and State of Rhode Island, bounded and described as follows:

Beginning at a point in the easterly line of Plainfield Street, said point being one hundred and ninety-nine and 00/100 (199.00) feet northerly from the intersection of the northerly line of Murray Street and the said easterly line of Plainfield Street, said point also being five and 00/100 (5.00) feet northerly from the southwest corner of land of this grantor, said corner being the intersection of the northerly line of a twenty (20) foot wide lane and the before mentioned easterly line of Plainfield Street; thence northerly along the said easterly line of Plainfield Street sixty-four and 00/100 (64.00) feet to other land of this grantor; thence easterly at right angles with the said easterly line of Plainfield Street twenty and 00/100 (20.00) feet to a point of curve; thence continuing in a general easterly direction curving to the left along the arc of a circle with a radius of one hundred and fifty and 00/100 (150.00) feet, a distance of fifty-three and seventy-two one hundredths (53.72) feet to a point in the westerly line of Nancy Street and bounded generally northerly on the last two described lines by the said other lands of this grantor; thence southerly along the westerly line of Nancy Street twenty-four and sixty-nine one hundredths (24.69) feet to a point of curve in the said westerly line of Nancy Street; thence continuing southerly along the said westerly line of Nancy Street along the arc of a circle curving to the left with a radius of one hundred and ninety and 00/100 (190.00) feet a distance of forty-one and twenty-one one hundredths (41.21) feet to the first named land of this grantor; thence generally westerly in an arc concentric with and sixty-four and 00/100 (64.00) feet southerly from the arc next last described, fifty-nine and forty-six one hundredths (59.46) feet to a point of tangency of the aforesaid concentric arc; thence continuing in a generally westerly direction on a line tangential to the arc last described, twenty and 00/100 (20.00) feet to the easterly line of Plainfield Street and the point and place of beginning. The last described line making an angle ninety (90) degrees with the beforementioned easterly line of Plainfield Street. Bounded southerly on the two last described lines by the said first named land of this grantor.

That certain tract or parcel of land situated on the easterly side of Nancy Street in the City and County of Providence and State of Rhode Island, bounded and described as follows:

Beginning at the tangent point of a curve in the easterly line of Nancy Street, said tangent point being forty and 00/100 (40.00) feet easterly from the point of curve in the westerly line of Nancy Street referred to in the description of Parcel A herein, said tangent point also being eighty-eight and twenty-six one hundredths (88.26) feet southerly from the northwesterly corner of land of this grantor; thence northerly along the said easterly line of Nancy Street thirty-nine and sixty-three one hundredths (39.63) feet to a point, said point being forty-eight and sixty-three one hundredths (48.63) feet southerly from the before mentioned northwesterly corner of land of this grantor; thence generally easterly curving to the right in the arc of a circle with a radius of three hundred and 00/100 (300.00) feet, a distance of ninety-five and 00/100 (95.00) feet to a point of tangency of said arc; thence continuing in a generally easterly direction along the tangent of the last described arc thirty-seven and ninety-two one hundredths (37.92) feet to a point on the arc next described; thence generally southerly, curving to the left along the arc of a circle with a radius of three hundred and two and 00/100 (302.00) feet a distance of sixty-six and seventy-six one hundredths (66.76) feet to a point; thence in a general westerly direction parallel with and sixty-four and 00/100 (64.00) feet southerly from the northerly boundary line of the parcel herein described a distance of fifty-seven and forty-seven one hundredths (57.47) feet to a point of curve; thence continuing in a generally westerly direction curving to the left in the arc of a circle concentric with and sixty-four and 00/100 (64.00) feet southerly from the northerly boundary line of the parcel herein described, a distance of ninety-two and sixty-six one hundredths (92.66) feet to the easterly line of Nancy Street; thence generally northerly along the said easterly line of Nancy Street in the arc of a circle curving to the right with a radius of one hundred and fifty and 00/100 (150.00) feet a distance of twenty-seven and thirty-seven one hundredths (27.37) feet to a point of tangency of the said arc in the easterly line of Nancy Street and the point and place of beginning.

The within described Parcel B is bounded westerly by the aforesaid Nancy Street and northerly, easterly and southerly by other land of this grantor.

TO HAVE AND TO HOLD the same with all the rights, privileges and appurtenances thereof or thereunto appertaining, unto and to the use of the said City of Providence, its successors and assigns forever, for the especial purpose of being used and improved as a PUBLIC HIGHWAY.

And the aforementioned Grantor, for itself and for its successors and assigns, hereby covenants with the said City of Providence, its successors and assigns that it will warrant and defend the aforescribed premises to

the said City of Providence, its successors and assigns forever, against the lawful claims and demands of all persons claiming by, through or under it.
