Dear Mayor:

During the fiscal year 1956-57 the Office of the Recorder of Deeds received for record 18,276 documents, including 114 Military Discharges for which no fee was charged. 18,162 documents then, brought in \$60,791.15 in fees.

Total expenditures for the fiscal year amounted to \$67,250.70. The net expenses to the City Government to operate the Office of the Recorder of Deeds for the fiscal year 1956-7 was \$6,459.55.

Much work has been done during the past fiscal year in rebinding many of the older record books and plat books. For this purpose \$6600.00 was spent, and for the microfilming of our current records an additional \$2000.00

It is interesting to note that these two extraordinary items accounted for more than enough expenditure to show an operating deficit in receipts versus expense for the past fiscal year.

Our big problem at the present time is lack of operating space. We had hopes of and have not yet dispaired of placing many of our older and least used volumes under State control, and substitute therefor microfilm copies thereof. Up to the present time the State Government has not seen fit to accept these books.

The result is that we are at present swamped with thousands of volumes which, for lack of space for book racks, have spilled over onto work tables and other facilities for which we have other uses.

It has now become imperative that if we are to continue to retain possession of all of our record books additional space must be provided for the same.

I would earnestly recommend that the entire fifth floor of City Hall be allocated at this time to the Office of the Recorder of Deeds in order to give us sufficient room for present operations and for a reasonable expansion of record facilities.
