## RESOLUTION OF THE PROVIDENCE WATER SUPPLY BOARD

3. An Ordinance making an Appropriation of Thirteen Million Seven Hundred Forty Seven Thousand Two Hundred Thirty Four Dollars (\$13,747,234) for the Water Supply Board Infrastructure Replacement Program Fund for the Fiscal Year Ending June 30, 2004, and
4. An Ordinance making an Appropriation of Four Million Two Hundred Sixteen Thousand Six Hundred Sixty Three Dollars (\$4,216,663) for the Water Supply Board Capital Fund for the Fiscal Year Ending June 30, 2004, and
5. An Ordinance making an Appropriation of Two Million Thirty One Thousand Seven Hundred Sixty Nine Dollars (\$2,031,769) for the Water Supply Board Insurance Fund for the Fiscal Year Ending June 30, 2004, and
6. An Ordinance making an Appropriation of Eight Hundred Sixty Three Thousand Three Hundred Thirty Nine Dollars (\$863,339) for the Water Supply Board Meter Replacement Fund for the Fiscal Year Ending June 30, 2004, and
7. An Ordinance making an Appropriation of Three Hundred Seventy Three Thousand Six Hundred Thirty Nine Dollars (\$373,639) for the Water Supply Board Alternative Supply Fund for the Fiscal Year Ending June 30, 2004, and
8. An Ordinance making an Appropriation of One Million Three Hundred Seventy Eight Thousand Seven Hundred Twenty Seven Dollars (\$1,378,727) for the Water Supply Board Equipment Replacement Fund for the Fiscal Year Ending June 30, 2004, and





10. An Ordinance making an Appropriation of One Million Seven Hundred Sixty Five Thousand Five Hundred Sixteen Dollars (\$1,765,516) for the Water Supply Board Chemical and Sludge Fund for the Fiscal Year Ending June 30, 2004, and
