Disposition: We are presently conducting a traffic survey at the intersections of Glover Street and Home Avenue and at Bolton Avenue and Home Avenue for a "STOP" control. The results of this survey will be available within two weeks. A work order has been written to install 25 M.P.H. signs along both Glover Street and Bolton Avenue.
