ELECTION OF JUDGE OF PROBATE COURT**

The City Council proceeds to elect the Judge of the Probate Court in accordance with the provisions of Section XI of Chapter 3340 of the Public Laws of 1954, approved April 26, 1954, entitled: "An Act in Amendment of Clause I of Section XI of Chapter 598 of the Public Laws, 1866, as amended, relating to the Probate Court of City of Providence".

JOHN E. MARTINELLI, ESQUIRE, only nominee, was nominated to succeed ANTHONY B. SCIARRETTA, ESQUIRE for the remainder of the term of Six (6) Years ending on the first Thursday in November, 1995, at the regular meeting of the City Council held on THURSDAY, AUGUST 3, 1995, which date has allowed for the elapsed time of twenty (20) days between the nomination and election of the Judge of Probate Court.

The nomination of JOHN E. MARTINELLI, ESQUIRE as Judge of the Probate Court is thereupon taken from the City Clerk's Desk on motion of COUNCILMAN IGLIOZZI, seconded by COUNCILWOMAN DIRUZZO.

The City Council thereupon proceeds to elect JOHN E. MARTINELLI, ESQUIRE only nominee, as Judge of the Probate Court of the City of Providence.

COUNCIL PRESIDENT PRO TEMPORE FARGNOLI thereupon declares JOHN E. MARTINELLI, ESQUIRE duly elected Judge of the Probate Court of the City of Providence for the remainder of the unexpired term due to the resignation of ANTHONY B. SCIARRETTA, ESQUIRE, ending on the First Thursday in November, 1995.
