



Resolution Honoring the Life of Suzanne Allison and extending Sincere Condolences to her family, friends, and loved ones.

*WHEREAS*, Born in Providence and raised on Pleasant Valley Parkway, Suzanne (Smith) Allison was a proud Rhode Islander and Providence resident; and

*WHEREAS*, The daughter of Annette (Trudeau) Smith and the late Walter Smith, she was an extremely talented and nationally recognized graphic artist; and

*WHEREAS*, Her career television broadcasting took her from local stations, including WJAR in Providence and WNEV in Boston, to the height of her profession working on national broadcasts for ABC News, where she worked on programs such as “This Week with David Brinkley” and “Nightline,” hosted by the legendary Ted Koppel; and

*WHEREAS*, In 1986, she married the man she frequently called her “soulmate,” Thomas (Kole) Kolodziejczak, an esteemed television journalist in his own right who worked at WJAR for many years; and

*WHEREAS*, In 2002, she received a Peabody Award, the most prestigious award in radio and television journalism, for her work on *The Heart of Darkness*, a five-part “Nightline” special on the great human tragedy and political conflict that occurred in the Democratic Republic of the Congo during the 2<sup>nd</sup> Congo War and in the wake of the Rwandan Genocide; and

*WHEREAS*, In 2012, Allison retired from her impressive professional career and returned to hometown; and

*WHEREAS*, An incredibly active and dedicated member of her community, Allison volunteered with many non-profit and civic organizations, and was instrumental to the founding of Friends of Pleasant Valley Parkway; and

*WHEREAS*, An avid dog-lover, Allison adopted many rescue dogs and helped to find loving homes for many more through her work with the animal rescue organization Save a Lab Rescue; and

*WHEREAS*, Tragically, Suzanne Allison passed away from lung cancer on June 7<sup>th</sup>, 2016 at the age of 64; and

*WHEREAS*, A beloved wife, daughter, sister, and aunt, in addition to her beloved husband, she was survived by her nephews, William Dorry, Mark Smith, Daniel Loiselle, Eric Smith, and John Coletta, and by her niece Monique Nunes.

**COUNCILWOMAN RYAN, COUNCILMAN IGLIOZZI, COUNCILWOMAN MATOS, COUNCILMEN PRINCIPE AND ZURIER**

Resolution Urging the Preservation of the Rhode Island Hospital Southwest Pavilion.

*WHEREAS*, Built in 1898, the Southwest Pavilion was the third building erected in the Rhode Island Hospital complex; and

*WHEREAS*, The Southwest Pavilion is the most intact surviving piece of the original Rhode Island Hospital and its construction was paid for almost entirely using community funds; and

*WHEREAS*, The red-brick, T-plan Southwest Pavilion was constructed to serve women and children, with wards for each and a playroom for the latter, and to house the hospital’s first pathological laboratory; and

*WHEREAS*, Intended to match the hospital’s original structure, built in 1864 and designed by local architect Alpheus C. Morse, the Southwest Pavilion represents late 19<sup>th</sup> century institutional architecture and demonstrates the intention of creating a visually integrated campus; and

*WHEREAS*, With its polychrome-stone drip-mold lintels over the windows, a large semi-duodecagonal-plan copper-clad bay window across its south elevation, and high, horizontally-striped slate hip roof with small dormers, octagonal-plan spired cupola centered on the ridgeline of the south wing, and square-plan peak roof above the west end of the north wing, the Southwest Pavilion is a beautiful example of High Victorian Gothic architecture; and

*WHEREAS*, The Southwest Pavilion’s significance is both historical and architectural, representing Rhode Island Hospital’s early steps toward the specialization and physical separation of programmatic activities that characterize modern medical campuses, as such it physically represents an important phase in the hospital’s historical development; and

*WHEREAS*, In 2015, Rhode Island Hospital announced its plan to demolish the Southwest Pavilion despite its important architectural and historical value; and

*WHEREAS*, The potential demolition of the Southwest Pavilion has brought on an outpouring of support from community members, patients, former and current hospital staff, and many others who feel that it is, as one patient put it, “The heart of the hospital campus”; and

*WHEREAS*, A petition to stop the demolition of the Southwest Pavilion has garnered more than 1,200 signatures; and

**WHEREAS**, The Providence Preservation Society (PPS) established a place on its website for people to post their “Community Memories of the Southwest Pavilion” that has pages of testimonials from local residents about the importance of this historic building to our community; and

**WHEREAS**, Many community groups, along with the Rhode Island School of Design and PPS, have offered numerous times to collaborate with Rhode Island Hospital to find a use for the Southwest Pavilion that is beneficial for both the hospital and the community; and

**WHEREAS**, There are many examples of modern hospitals successfully embracing their historic fabric for the betterment of their patients and their communities, including Johns Hopkins Hospital, which preserved its original structure as a billing and administrative center, and prominently highlights its reuse in its promotional materials; and

**WHEREAS**, In a letter dated April 21, 2016, the Executive Director of PPS reiterated that much of the Rhode Island Hospital campus was paid for with community funds and stated, “To demolish [the Southwest Pavilion] without the community’s input is an insult to the very people who helped the Hospital become what it is today”; and

**WHEREAS**, As the elected representatives of the people of Providence, the City Council has a moral obligation to honor and preserve the landmarks and historically significant structures that connect us to our past and make our city a vibrant, beautiful, and unique place to live.

**NOW, THEREFORE, BE IT RESOLVED**, That the City Council of the City of Providence does hereby strongly urge Rhode Island Hospital and Lifespan to consider all options and do everything in their power to preserve the historic Southwest Pavilion.

## COUNCILMAN SALVATORE

Resolution Requesting the Department of Public Works to investigate and address rat related issues in Ward 14.

**WHEREAS**, There has been a recent spike in rat-related issues in the 14<sup>th</sup> Ward of Providence, with more than a dozen complaints logged in less than a three-week period; and

**WHEREAS**, In June, investigations by both Channel 10 and the Valley Breeze revealed a serious rat infestation in North Providence along the Woonasquatucket River, which flows into Providence; and

**WHEREAS**, Rats are a major carrier of dangerous diseases, such as salmonellosis, leptospirosis, murine typhus, rat bite fever, and plague; and

**WHEREAS**, According to Channel 10, the rat infestation in North Providence has already exposed some household pets to leptospirosis, a bacterial infection that affects both humans and animals and can cause kidney damage, meningitis, liver failure, respiratory failure, and death; and

**WHEREAS**, In addition to carrying disease, rats cause a great many other problems in our community, such as digging burrows that cause stability issues for homes and buildings, chewing through wood and wires, blocking sewer lines, and spoiling yards and gardens; and

**WHEREAS**, As the elected representatives of the people of Providence, the City Council has a moral obligation to protect our city from hazards such as rat infestations.

**NOW, THEREFORE, BE IT RESOLVED**, That the Providence City Council does hereby request that the Department of Public Works investigate and eliminate the cause of the recent increase in rat-related complaints in Ward 14.

**BE IT FURTHER RESOLVED**, That, upon passage, a copy of this letter be sent to the Director of the Department of Public Works.


