LOT 373 ON ASSESSOR'S PLAT 78, 9 HOUGHTON STREET.


Approved November 14, 2003

Be it ordained by the City of Providence:

1. That Chapter 200-6 of the Ordinance of the City of Providence approved
March 23, 2006 and entitled "An Ordinance approving and adopting the
Official Redevelopment Plan for the Wanskuck Redevelopment Project" be
and the same is hereby amended as follows:
 - A. To the Wanskuck Redevelopment Ordinance, the following parcel shall be
immediately added to the project for acquisition:

entitled "Acquisition Map" shall be amended to include the Proposed
Acquisition of the aforementioned properties.

adopted and as heretofore amended, be and the same is hereby ratified and
affirmed in all other respects.
3. This Ordinance shall take effect on its passage and shall be filed with the City
Clerk who is hereby authorized and directed to forward a certified copy
thereof to the Providence Redevelopment Agency.
