No. 201 **AN ORDINANCE** IN AMENDMENT OF THE APPROPRIATION ORDINANCE CHAPTER 1978-18, APPROVED JULY ~~18~~<sup>28</sup>, 1978, BY TRANSFERRING THE SUM OF FORTY THOUSAND DOLLARS, (\$40,000.00) FROM 5-350, WATER DEPRECIATION AND EXTENSION FUND, TO 1-16-03-272, HYDRANTS, VALVES AND FITTINGS, WITHIN THE WATER SUPPLY BOARD. *Am m*

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1978-18 of the Ordinances of the City of Providence, Approved July ~~18~~<sup>28</sup>, ~~1977~~<sup>1978</sup>, and entitled, "An Ordinance Making Appropriation of One Hundred Fourteen Million, Nine Hundred Ninety Eight Thousand, Eight Hundred Fifty Dollars, Ninety Two Cents, (\$114,998,850.92) for the Support of the City Government for the Fiscal Year Ending June 30, 1979, as amended", is hereby further amended by transferring a certain sum of money within the Water Supply Board as follows: *R m m*

FROM	5-350	Water Depreciation & Extension Fund	\$40,000.00
TO:	1-16-03-272	Hydrants, Valves & Fittings	\$40,000.00

SECTION 2. This Ordinance shall take effect upon its passage by the City Council and its approval by the Mayor.
