

# RESOLUTION OF THE CITY COUNCIL

Approved May 7, 1954

Resolved,

That

His Honor the Mayor be, and he hereby is, authorized to enter into an agreement for the sale to the Standish-Barnes Co. of lot 18 on Assessor's Plat 126, located at Mashpaug Pond, excepting the area occupied by the spillway thereon, and a ten-foot strip on either side of said spillway, the total area to be conveyed containing approximately 30,000 square feet. The price to be paid by the purchaser shall be fifteen (15¢) cents per square foot of land conveyed. Said agreement shall be subject to such terms and conditions as may be approved by the Mayor and Director of Public Works and shall include the following:

1. Agreement of the Standish-Barnes Co. to undertake and complete within one year from execution of sales agreement of adequate drainage piping Mashpaug Brook from the spillway on Mashpaug Pond through existing City property to Reservoir Avenue, according to plans approved by the City Engineer of the City of Providence, and to maintain the same.
2. Revision and retention by the City of Providence of existing right of access to the spillway, so-called.
3. Grant by the Standish-Barnes Co. of such easements and/or rights of way as may be deemed necessary or desirable by the City of Providence for its own use and enjoyment or that of such owners or occupants of adjoining land as it may designate.

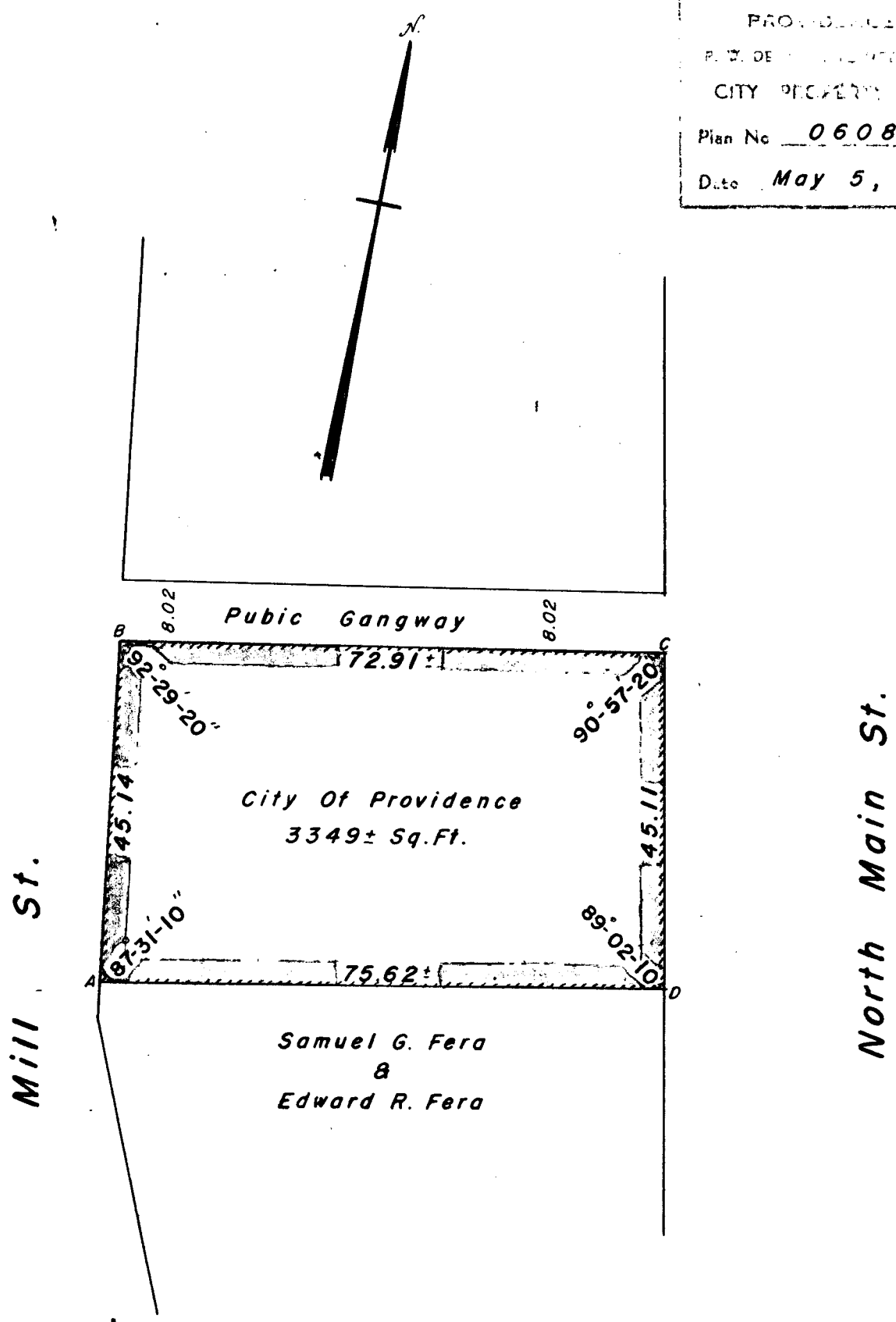

# RESOLUTION OF THE CITY COUNCIL

No. 287

Approved May 7, 1954

Resolved,

That the City Council of the City of Providence hereby orders the assessment and collection of a tax on the ratable real estate and tangible personal property and ratable intangible personal property (the tax on ratable intangible property to be at the rate of forty cents on each one hundred dollars of the value thereof) in a sum not less than \$20,300,000.00 nor more than \$20,800,000.00; said tax is for ordinary expenses, charges and sinking funds, for the payment of interest and indebtedness in whole or in part of said City, and for other purposes authorized by law.

The City Assessor shall assess and apportion said tax on the inhabitants and ratable property of said City as of the 31st day of December, A. D. 1953, at twelve o'clock noon, Eastern Standard Time, according to law, and shall, on completion of said assessment, date and sign the same, and shall make out and certify to the City Collector of the City of Providence, on or before the 15th day of June, A. D. 1954, a complete list of the names of the persons taxed and of the total value of all the real estate taxed to each person, also the amount of personal estate assessed against each person, and also the total amount of the tax assessed against each person on said real estate and personal estate, opposite the name of the person or persons assessed, the assessment of real estate and of personal estate to appear in separate columns in said list. Said tax shall be due and payable on and between the 1st day of October, next and the twenty-fifth day of October, A. D. 1954, next, and all taxes remaining unpaid on said last named day shall carry until collected a penalty at the rate of eight per centum per annum upon such unpaid taxes. Provided, however, said tax may be paid in four installments, the first installment of twenty-five per centum on or before the twenty-fifth day of October, A. D. 1954, and the remaining installments as follows: Twenty-five per centum on the twenty-fourth day of January, A. D. 1955; twenty-five per centum on the twenty-fifth

day of April, A. D. 1955; and twenty-five per centum on the twenty-fifth day of July, A. D. 1955. Each installment of taxes, if paid on or before the last day of each installment period successively and in order, shall be free from any charge for interest. If the first installment or any succeeding installment of taxes is not paid by the last date of the respective installment period or periods as they occur, then the whole tax or remaining unpaid balance of the tax, as the case may be, shall immediately become due and payable and shall carry until collected a penalty at the rate of eight per centum per annum. The City Collector shall, by advertisement, in the public newspapers of the City, notify all persons assessed to pay their respective taxes at his office on and between the said 1st and twenty-fifth days of October, A. D. 1954, both days inclusive; said Collector shall attend daily during said periods, Saturdays, Sundays and Holidays excepted, at his office from nine o'clock A. M. to five o'clock P. M. to receive said taxes.
