## CHAPTER 1973-25

No. 295 **AN ORDINANCE** in amendment of and in addition to Chapter 1419 of the ordinance of the City of Providence, approved August 11, 1961, and entitled "An Ordinance approving and adopting the Official Redevelopment Plan for the Central-Classical Project No. R.I. R-2".

Approved June 11, 1973

### Be it ordained by the City of Providence:

1. That Chapter 1419 of the Ordinances of the City of Providence, approved August 11, 1961 and entitled "An Ordinance approving and adopting the Official Redevelopment Plan for the Central-Classical Project No. R.I. R-2" as heretofore amended, be and is hereby further amended as follows:

A. A certain Section of the aforementioned Official Redevelopment Plan hereinafter identified is deleted:

1. Section C.2.a.(1)(d) Maximum Land Coverage in the R-4 Multiple Residence Zone on Page 5 of the Official Redevelopment Plan.

Insert the following in its stead:

C.2.a.(1)(d) Maximum Land Coverage-shall be governed by applicable provisions of the Zoning Ordinance of the City of Providence.

2. That said Chapter 1419 of the Ordinance of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.

3. That this ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.
