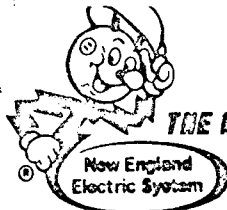



With the help and encouragement of concerned
citizens, Providence should continue to be one of
the pace-setters in the nation-wide effort toward
Urban Renewal.

Here's what's happening on the East Side...

Signs of progress are visible everywhere in Providence — and the East Side is really just a beginning!

As a result of the Loan and Grant Contract signed this year with the Federal Government, complete redevelopment of over 300 acres on Providence's East Side has begun.

The funds from this contract will be used in transforming the Randall Square area into a new 60-acre industrial development that will help to broaden the city's tax base, and for extensive rehabilitation in the Fox Point neighborhood.

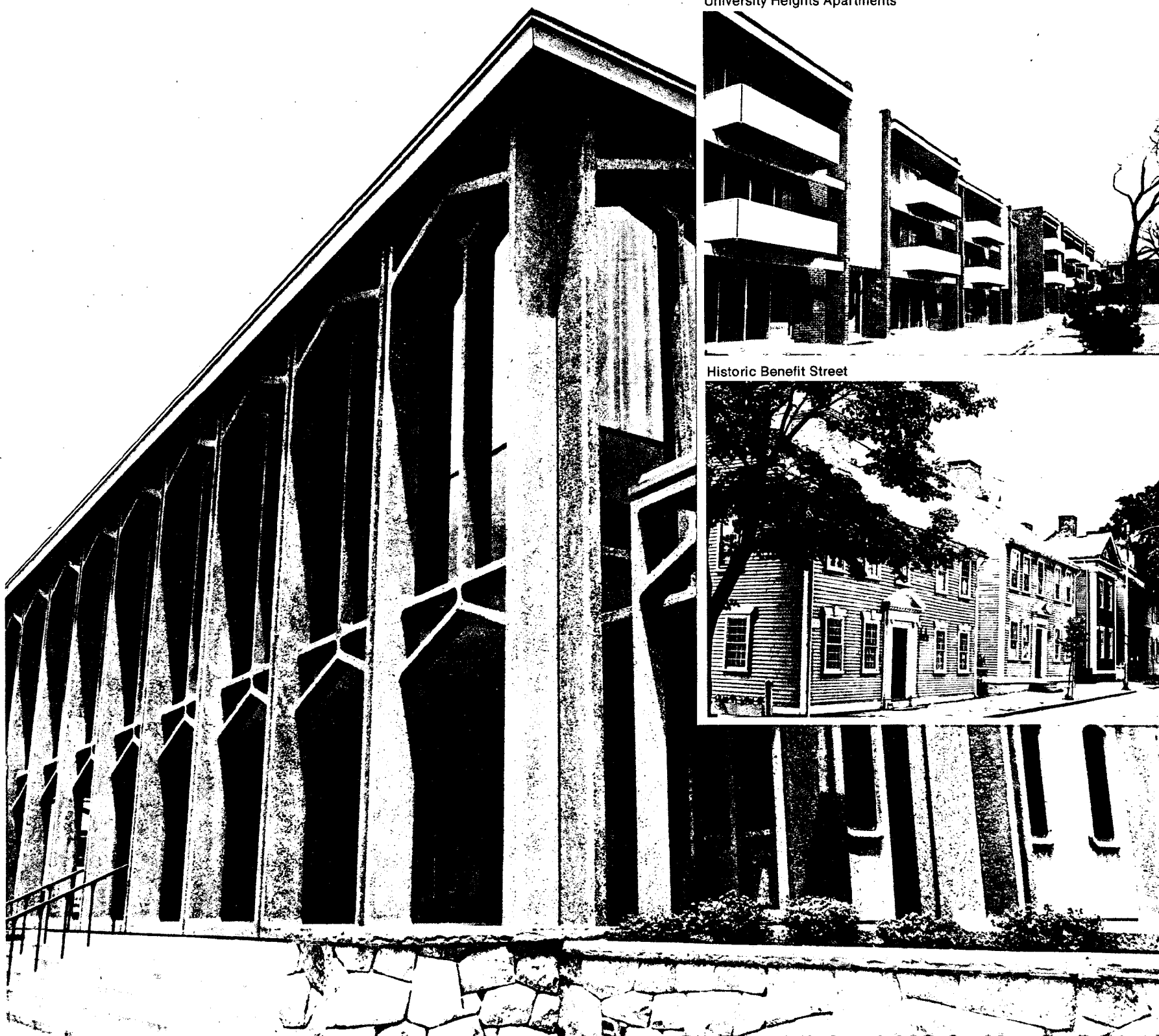
Soon the historic Roger Williams Spring will form the center of a new national park across North Main Street from the expanding facilities of the Episcopal Diocese of Rhode Island.

Still more progress has been made in the further development of plans for the redevelopment of the South Main Street and South Water Street areas.

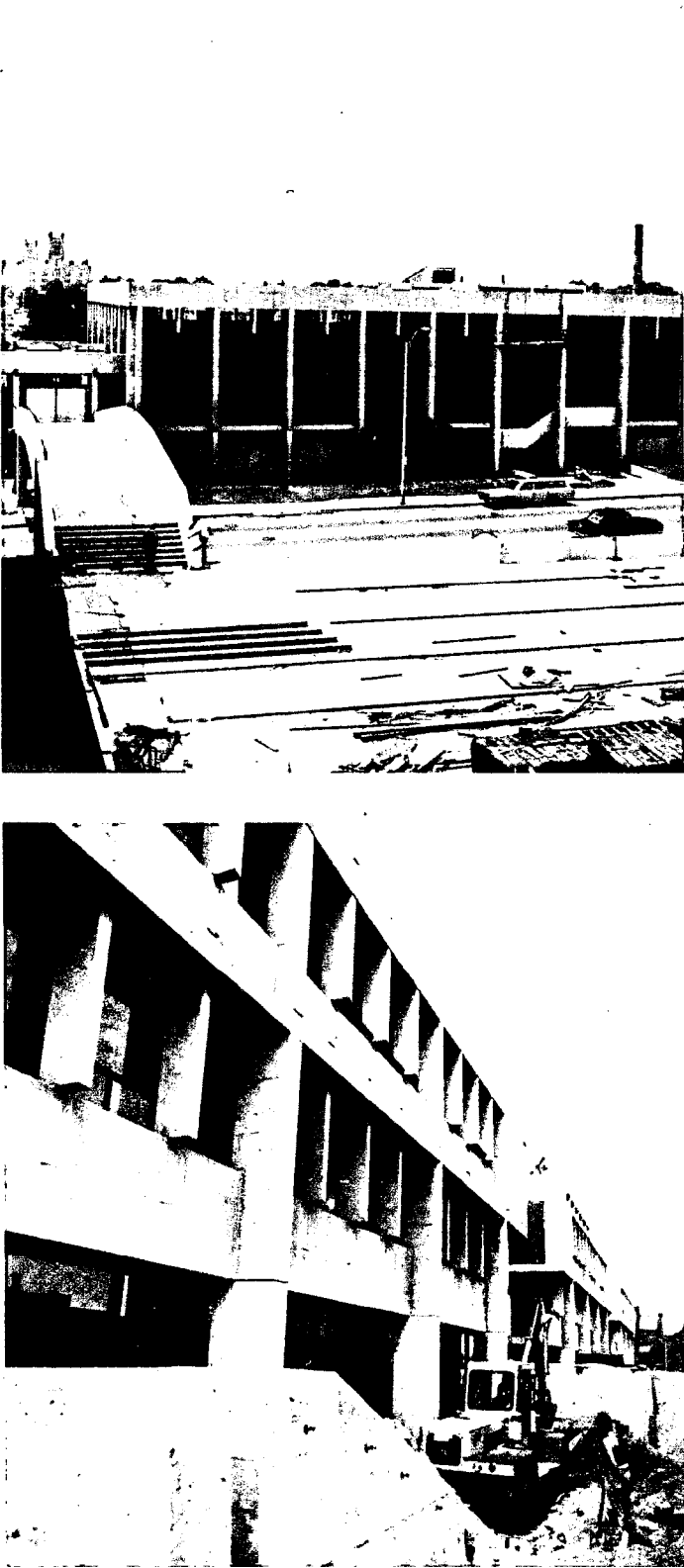

The new "planned neighborhood," Wiggin Village, an essential part of the entire Central-Classical Project, is expected to reach completion within the coming year, with over 120 families already residing there. This particular project is an outstanding example of a serious effort by a private (non-profit) sponsor to develop quality housing for low and moderate income families in Providence.



Here's what's happening at Huntington Park...

The Huntington Expressway Industrial Park — also known as the Mashapaug Pond area — has been the site of continued industrial development during this past year.

By the end of 1967, 10 new plants had been completed and occupied, and two more plants are presently nearing completion. All this multiplies the area's tax revenue for the city, as has also been evidenced at West River Industrial Park.

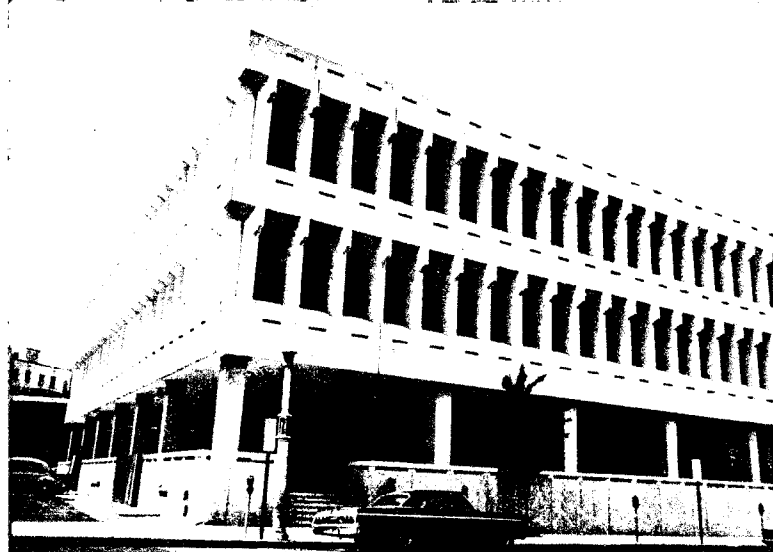

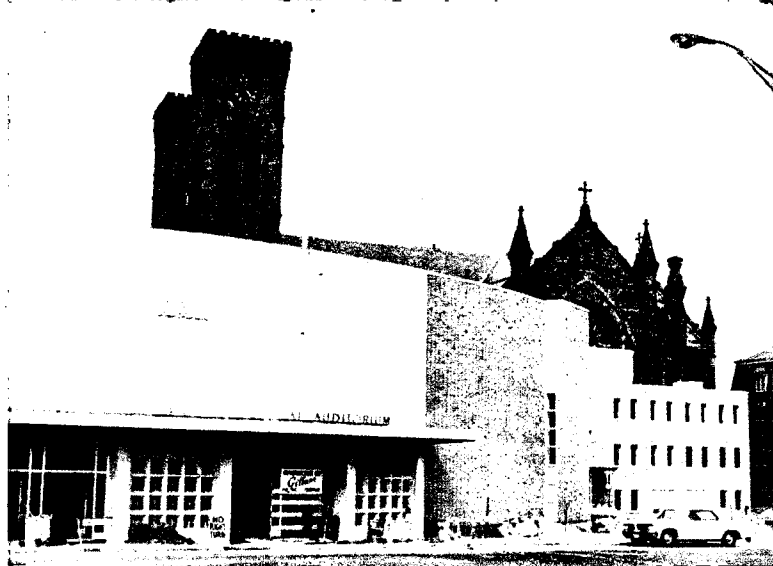

Here's what's happening on Mount Hope and West Broadway...

Major public improvements are planned for Mt. Hope, an area which has been hampered by overcrowding, poor streets and a shortage of recreational facilities for people of all ages.

Extensive rehabilitation and conservation treatment is planned for this entire area, and except for some "spot clearance locations" of a few residential structures, no broadscale relocation and demolition is anticipated.

West Broadway is another area where a thorough program of rehabilitation is planned. Clearance and displacement will be kept to a minimum on this project, with emphasis instead being placed upon the rehabilitation and conservation of existing structures.

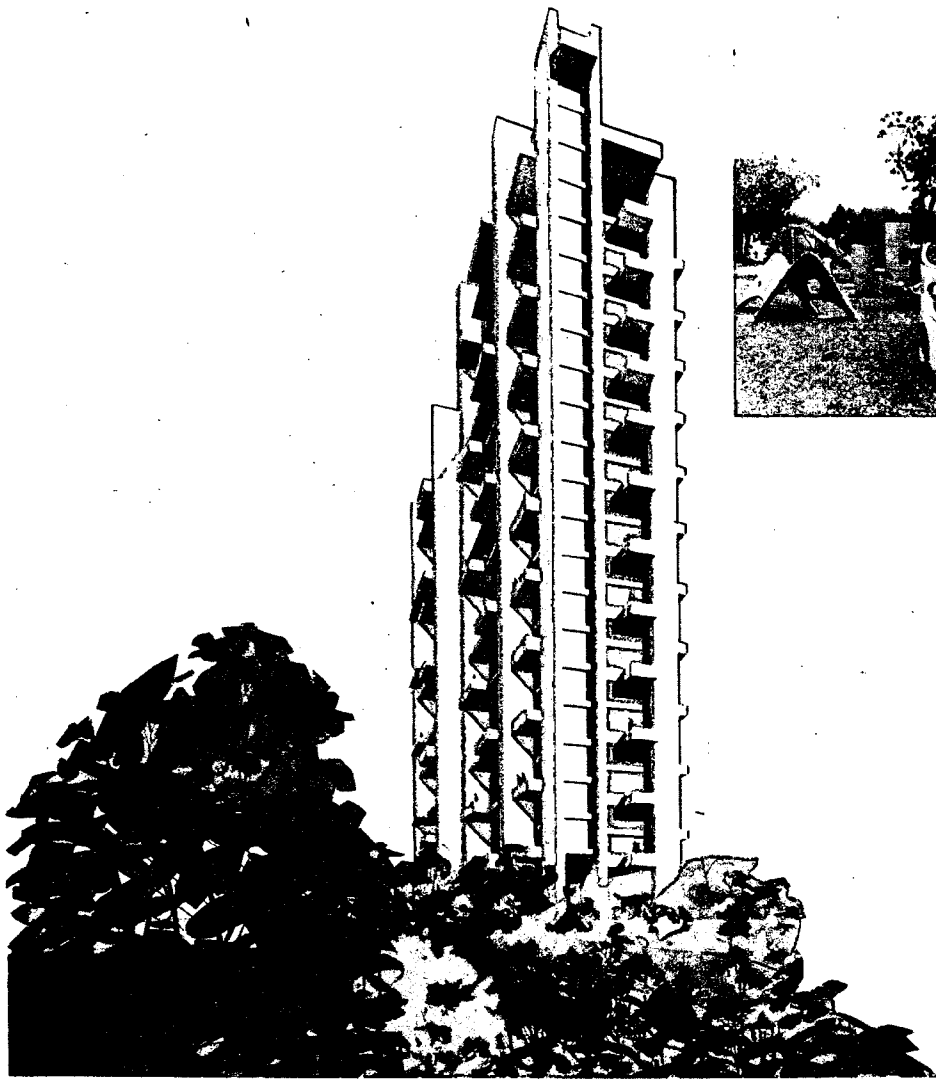

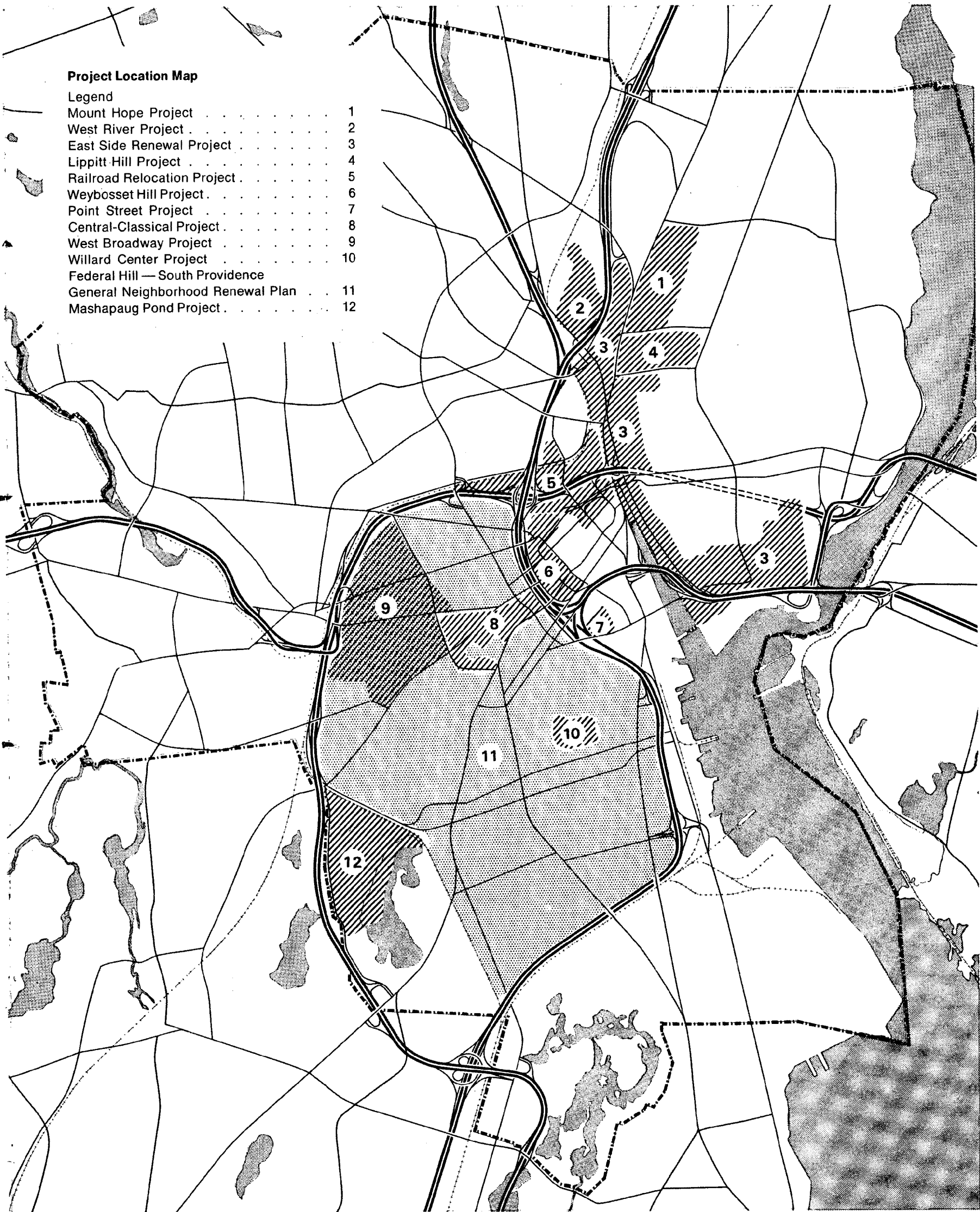

In this, its 20th year of working for urban renewal and rehabilitation in our city, the Providence Redevelopment Agency is pleased to report that 1967 has seen several major building projects carried to the point of completion, or near completion.

Monies from four redevelopment bond issues approved by the voters of Providence are paying the City's share of the cost for all of the projects which have been undertaken. These bonds are self-liquidating through the additional revenue realized from an increased tax base. Specifically these projects include: Point Street, Willard Center I & II, Lippitt Hill, Mashapaug Pond, West River, Central-Classical, Weybosset Hill, the East Side and Mt. Hope.

Now, additional monies are needed to continue rebuilding in the general area covered in the approved General Neighborhood Renewal Plan. Specifically this area includes West Broadway, Federal Hill, Elmwood and South Providence. We believe that the citizens of Providence will wish to give their full support to the continued renewal and growth of their City, not only by approving an essential new bond issue, but by participating in the planning and subsequent private investment which are so necessary to continue the Providence redevelopment programs. These are the programs that will help shape our City's future and provide a significant return without adding to the burden of Providence taxpayers.
