Resolution Respectfully Requesting the Mayor to Comply with the Provisions of Section 2 of Chapter 1976-15, Approved April 13, 1976, Relative to the Expenditure of All Monies Received by the City from the Federal Government for Community Development Block Grant Entitlement Funds, for the Fiscal Year, 1977.

*Resolved*, That His Honor the Mayor is respectfully requested to comply with the Provisions of Section 2 of Chapter 1976-15, approved April 13, 1976, Relative to the expenditure of all monies received by the City from the Federal Government for Community Development Block Grant Entitlement Funds for the Fiscal Year, 1977, as follows:

*Section 2.* All monies received by the City of Providence from the Federal government under the provisions of Section 106 (a) or (h) of Title I of the Housing and Community Development Act of 1974, (Public Laws 93-383), shall be expended in accordance with the provisions of said Act and shall be by Ordinance of the City Council. The Citizens Advisory Committee may comment on the plan for expenditure of funds so received. The City Council will consider the views of the Citizens Advisory Committee, but it shall retain to itself the final approval for the expenditure of funds. No funds received under said Act shall be allocated for specific projects nor expended without the approval of the City Council.
