

Recreating these details and learning a new software would be extremely time consuming. I have discussed the cost of the plotter/cutter with the plotter manufacturer and the price quoted in the attached quote is consistent with the cost the plotter/cutter manufacturer charges. Based on this I believe the price quoted in the attached quote reflects the market value.




This letter is written pursuant to our conversation and your questions regarding URW, our products and services.


