Pursuant to your instructions I had Ptlm. Joseph Keating conduct a survey for the proposed School Crossing Post on Bucklin Street at Gilbert Stuart Junior High School, and he reported the following:

Vehicles going south on Bucklin St.	=	<u>104</u>
Children crossing Bucklin St..	=	<u>65</u>
<u>11:30 a.m. - 11:45 a.m.</u>		
Children dismissed	=	<u>0</u>
Children returning to school	=	<u>2</u>
<u>2:30 p.m. - 2:45 p.m.</u>		
Vehicles going north on Bucklin St.	=	<u>38</u>
Vehicles going south on Bucklin St.	=	<u>43</u>
Children crossing Bucklin St.	=	<u>47</u>

There is no parking on either side of Bucklin Street, and this regulation was instituted to provide for the safety of the children several years ago, and that is one of the reasons I would not recommend a crossing guard post be established at this location. The other reasons are; the officer reports vehicular traffic was light at the time children were crossing this street, only in the morning was there substantial number of children crossing which is an indication that they must cross at different locations during the course of the day, also; because of the man-power shortage in the department it would further tax this department to provide a substitute if the crossing guard should be sick.



Subject: Report of Survey (Proposed School Crossing Post Oxford & Gordon)

Sir: Pursuant to your instructions a survey was conducted by Ptlm. Bruce M. Knight, October 29, 1968, at Oxford Street & Gordon Avenue a proposed location for a school crossing post with the following results:

<u>Time</u>	<u>Number Children Crossing</u>
8:00 A.M. to 8:30 AM	178 (37 vehicles used highway)
2:25 P.M. to 3:05 PM	263 (18 vehicles used highway)

At this location there were (3) young male monitors stopping traffic and crossing school children.

This location is not a main highway, and because of the few vehicles passing this intersection I would not recommend that a school crossing post be established, because it would further tax this department to cover if the guard should become sick due to the shortage of manpower that would be required if a crossing guard who is a spare is not available when we have more than normal sickness during the winter months. Another reason I would not recommend this corner be established is that we have a crossing guard at Prairie Ave. & Oxford which is one block away and the children who wish to cross Oxford St. could be instructed to go to that location and she will cross them.



Dear Mayor Doorley:

The Bureau of Licenses submits herewith a report of its activities for the year ending December 31, 1968.

The Bureau has authorized the issuance of 9,560 licenses of various types.

It has held approximately 154 informal hearings.

The Bureau has attended pre-views of motion pictures, after regular hearings and on mornings, other than regular hearing days totalling 10 days; the Bureau made several appearance at court, in the interest of determining questionable obscenity.

In addition, The Bureau conducted 90 formal hearings, to which licensees were summoned by the Bureau for violations of various kinds-violations of the provisions of State Statutes, Ordinances of the City of Providence, or Rules and Regulations of the Bureau of Licenses. Many were continued from the original hearing date, due to incomplete records presented, etc.

At these formal hearings, witnesses were summoned-police and other interested parties. In approximately 50% of the violations that were heard, licensees were represented by Counsel. An assistant City Solicitor represented the Police Department. Witnesses were sworn, testimony was taken, both direct and by cross-examination, and subsequently the members of the bureau, discussed in executive session all said cases, after which they announced their decision.

For various reasons, cases were continued from time to time at the request of counsel, illness of licensee or interested parties, but usually-and this is a strict rule of the Bureau, licensees and applicants for licenses whose applications were not approved, were given prompt hearings.
