An Ordinance in Amendment of and in Addition to Chapter 1797 of the Ordinance of the City of Providence, Approved November 7, 1966, and Entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for the East Side Project No. R.I. R-4."

Be it ordained by the City of Providence:

1. That Chapter 1797 of the Ordinances of the City of Providence, approved November 7, 1966, and entitled "An Ordinance Approving the Official Redevelopment Plan for the East Side Project No. R.I. R-4" as heretofore amended, be and is hereby further amended as follows:

A. Delete paragraph (b) "Institutional uses are excluded from this C-4 district, in Section

III B.3.b. (1) Permitted Uses in C-4 Heavy Commercial Zone in South Main-South Water Section on page 18 of the Official Redevelopment Plan for the East Side Project.

B. Delete Map No. 2; Sheet 2 of 2, "Proposed Land Use and Zoning" revised 9-14-72;

C. Insert Map No. 2; Sheet 2 of 2, "Proposed Land Use and Zoning" revised 10-7-75.

2. That said Chapter 1797 of the Ordinance of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.

3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to for-

ward a certified copy thereof to the Providence Redevelopment Agency.

An Ordinance in Amendment of the Appropriation Ordinance Chapter 1974-19, Approved June 19, 1974, by Appropriating a Sum Not to Exceed Fifty Thousand Dollars (\$50,000.00) to Law Department—Special Item 3, for Claims Against the City of Providence.

Be it ordained by the City of Providence:

Section 1. Chapter 1974-19 of the Ordinances of the City of Providence, as approved June 19, 1974, entitled, "An Ordinance making appropriation of \$85,823,307.71 for the support of City Government for the fiscal period beginning July 1, 1974, and ending June 30, 1975" (July 1, 1975-June 30, 1976) as amended is hereby further amended by appropriating sum not to exceed Fifty Thousand Dollars (\$50,000.00) to Law Department—Special Item 3, for Claims against the City of Providence.

Sec. 2. The said sum not to exceed Fifty Thousand Dollars (\$50,000.00) as thus added and appropriated shall be obtained by authorizing the City Controller and City Treasurer to transfer such amount from the Reserve for Ex-

traordinary Expenditures Account to the Receipt Account.

Sec. 3. The estimated Receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by a sum not to exceed Fifty Thousand Dollars (\$50,000.00).

Sec. 4. This Emergency Ordinance shall take effect upon its adoption by the Council and its Approval by the Mayor.

I had it donated at no cost, I did all of the work, it was my project, and I want to say if Lieutenant Riccitelli could rise from his grave, he would shoot a few people.

COUNCILMAN ALMAGNO Requests and is Granted the Privilege of the Floor and Makes the Following Remarks:

COUNCILMAN ALMAGNO. I know Riccitelli personally. No. 1, Mr. Grande, if you want to check, has been living there for the last five

years. Mr. Grande wrote that article for the Journal and I saw the return article before it went in the paper, they okayed it. I didn't know he was a scholar.

As far as Riccitelli Square, I think it was done by the City at a very minimum fee, in fact for practically nothing, and it was in Committee for 10 years to have it done.

All of a sudden, he got excited and he starts hollering that the Mayor took it away from him. What did he take away from him, all he did was put cobblestones in. Mr. Riccitelli did the landscaping, and so forth.
