**COUNCILMAN JENNINGS, (By Request):**

An Ordinance Relating to Article IV, Chapter 17, Section 17-189(6) of the Code of Ordinances. (Disability Waiver Request).

SECTION 1. Notwithstanding the language of Section 17-189(6) of the Code of Ordinances which provides that the application to accomplish such [accidental disability] retirement must be filed within eighteen (18) months of the date of the accident," the Retirement Board of the City of Providence, may consider and act upon the accidental disability retirement application of Gloria O. Ciprian, even though more than eighteen (18) months have passed since the date of the accident which is the averred proximate cause of the above-named applicant for a disability retirement allowance.

SECTION 2. Said application shall be subject to and considered in accordance with all other applicable ordinances, regulations, standards and practices relating to accidental disability retirement applications.

SECTION 3. This Ordinance shall take effect upon its passage.

*WHEREAS*, Bannister House currently employs 130 dedicated and experienced health care staff, many of whom are Providence residents who work hard, raise their children in Providence, support their own families, and contribute to the economic life of our city and its neighborhoods; and

*WHEREAS*, Ninety residents receive compassionate long-term care at Bannister House; and

*WHEREAS*, The family and friends of these residents rely on Bannister House to provide a convenient location to visit their loved ones; and

*WHEREAS*, The Bannister House property is a significant building, that if vacated and left empty would be detrimental to the surrounding residential neighborhood; and

*WHEREAS*, Bannister House was recently placed in receivership and may be forced to close, displacing residents and terminating employees.

*NOW, THEREFORE, BE IT RESOLVED*, That the City Council of the City of Providence does hereby urge the Rhode Island General Assembly to do everything in its power to keep Bannister House in operation.

Resolution Requesting that the Administration submit a budget that adequately addresses the Providence Community Library's request for \$250,000.00 in additional funding in the coming year.

*WHEREAS*, The Providence Community Library provides free, accessible library services to improve and enrich the lives of the people of Providence; and

*WHEREAS*, The Providence Community Library network of nine branches serve as vibrant hubs within the neighborhoods of Providence, providing programs and services that respond to the needs of the community; and

*WHEREAS*, The Providence Community Library offers a unique combination of resources, knowledge and opportunities under nine roofs dispersed throughout the neighborhoods of the City; and

*WHEREAS*, The Providence Community Library network provides a vital learning center for children and adults, and a convenient gathering place for citizens and neighbors; and

*WHEREAS*, The City's budgetary contribution to the Providence Community Library system during the current fiscal year is \$3.545 million, or less than 0.6% of the City's budget. In contrast, according to data assembled by the Providence Community Library, peer cities such as Boston, Bridgeport, Hartford and Stamford allocate more than twice as much, on a percentage basis, than does Providence; and

*WHEREAS*, The City's budgetary contribution to public libraries is less than \$20 per Providence resident. In contrast, according to data assembled by the Providence Community Library, peer cities such as Boston, Bridgeport, Hartford and Stamford allocate between \$47.69 and \$65.95 per resident; and

*WHEREAS*, The Providence Community Library has engaged in extensive private fund raising and grant writing; however, the current level of municipal funding complicates and perhaps compromises its ability to maintain quality programming; and

*WHEREAS*, The Providence Community Library has requested a funding increase this year of \$250,000 to maintain its program.

***NOW, THEREFORE, BE IT RESOLVED***, That the Providence City Council requests that the administration submit a budget that adequately addresses the Providence Community Library's request for \$250,000 in additional City funding in the coming year.

Resolution Requesting the Administration to include in its tax levy ordinance a penalty provision that is more fair and reasonable than the current one.

*WHEREAS*, The City's tax levy ordinance enacted each year prescribes the penalties imposed on taxpayers whose payments are late; and

*WHEREAS*, The current tax levy ordinance contains a penalty provision which provides that:

If the first installment or any succeeding installment of taxes is not paid by the last day of the respective installment period or periods as they occur, then the whole tax or remaining unpaid balance of the tax, as the case may be, shall immediately become due and payable and shall carry until collected a penalty at the rate of twelve percent (12%) per annum on said real estate, personal estate and excise taxes; and

*WHEREAS*, This provision causes the entire year's tax to be due immediately if a taxpayer misses the first quarter's payment by as little as one day; and

*WHEREAS*, For example, this provision then charges 12% interest on the entire tax bill going forward, even if the taxpayer's delinquency was limited to a single day on the first quarter's payment; and

*WHEREAS*, For example, a taxpayer who made the first quarter payment one day late and then made all three other quarterly payments on time would still face a delinquency penalty of 10% of the entire tax bill; and

*WHEREAS*, The application of this penalty can have devastating financial effects on City residents who act in good faith.

*NOW, THEREFORE, BE IT RESOLVED*, That the City Council asks the administration to include in its tax levy ordinance a penalty provision that is more fair and reasonable than the current one.

*WHEREAS*, The Providence Public Schools are committed to quality education for all children, and

*WHEREAS*, The School Department's educational mission includes personal development as well as academic achievement, and

*WHEREAS*, Competitive sports provide an incomparable setting for personal development, and

*WHEREAS*, Competitive sports also can boost children's interest in school and interaction with positive role models, and

*WHEREAS*, Competitive sports can be particularly beneficial in the middle school years, in which children need to navigate the challenges of adolescence and peer pressure; and

*WHEREAS*, The Providence Public Schools, despite their financial challenges, operate a middle school sports program on a shoestring budget that serves approximately 600 student-athletes out of approximately 5,300 middle school students; and

*WHEREAS*, The cost for the program is currently around \$12,000 per year, and could be improved with an additional \$13,000 per year; and

*WHEREAS*, The upper range of this budget represents less than \$50 per student-athlete per year, less than \$5 per middle school student per year, less than .02% of City's contribution to the School Department budget (\$125 million) and less than .01% of the overall School Department Budget (\$350 million plus); and

*WHEREAS*, Notwithstanding these enormous benefits and modest costs, the School Department does not have a dedicated budget line item for middle school sports.

***NOW, THEREFORE, BE IT RESOLVED***, That the Providence City Council urges the School Department to include a permanent line item in its budget for middle school sports in the range of \$12,000 - \$25,000.

*WHEREAS*, The Providence Public Schools are committed to quality education for all children, and

*WHEREAS*, The School Department's educational mission includes personal development as well as academic achievement, and

*WHEREAS*, Competitive sports provide an incomparable setting for personal development, and

*WHEREAS*, Competitive sports also can boost children's interest in school and interaction with positive role models, and

*WHEREAS*, Competitive sports can be particularly beneficial in the middle and high school years, in which children need to navigate the challenges of adolescence and peer pressure; and

*WHEREAS*, The Providence Public Schools cannot afford to participate in the State's middle school interscholastic athletic program due to high costs, particularly the cost of middle school athletic coaches as stipulated in the Providence Teachers Union contract; and

*WHEREAS*, The Providence Teachers Union contract calls for middle school athletic coach compensation in the amount of 10% of salary, which translates to between \$3,800 and \$7,600; and

*WHEREAS*, The School Department's current middle school sports program attracts talented and dedicated coaches who are willing to provide their services for stipends of \$1,000 or less; and

*WHEREAS*, The rate for Providence teachers is significantly higher than neighboring communities such as Cranston (\$3,000 plus or minus \$100) and Pawtucket (\$1,700 to \$2,500); and

*WHEREAS*, The Providence Teachers Union Contract is currently in mediation.

***NOW, THEREFORE, BE IT RESOLVED***, That the Providence City Council hereby urges the administration to negotiate changes in the compensation for middle school sports coaches that would meet Statewide norms for affordability and which would support the participation of Providence's middle school students in the State's interscholastic middle school sports leagues.

Resolution Endorsing and Urging Passage by the General Assembly of House Bill 2015 H-5819 and Senate Bill 2015 S-0269, An Acting Relating to Motor and Other Vehicles - Comprehensive Community - Police Relationship Act of 2015.

*WHEREAS*, In March of this year, the United States Department of Justice published a report documenting racial profiling and violations of civil rights in the Ferguson, Missouri police department, and

*WHEREAS*, In December of last year, the United States Department of Justice published new rules for federal law enforcement to curb incidents of racial profiling; and

*WHEREAS*, During the past twelve months, police shootings of unarmed civilians in Ferguson, Missouri, Staten Island, New York and Cleveland, Ohio, among other places, have raised concerns nationally about police practices and the protection of civil rights, and

**WHEREAS**, The Rhode Island General Assembly has, for the past several years, considered legislation to enhance civilian protections against wrongful arrest, and to collect data to examine the possibility of disparate racial impact in arrest statistics, and

**WHEREAS**, The Rhode Island Senate passed the 2014 version of this legislation, but the legislation did not gain passage from the Rhode Island House of Representatives, and

**WHEREAS**, Representatives Almeida, Abney, Diaz, Maldonado and Williams have introduced, as Bill 2015 H-5819 (copy attached) and Senators Metts, Pichardo, Jabour, Miller and Lombardi have introduced, as Bill 2015 S-0269 (copy attached), the Comprehensive Community Police Relationship Act of 2015 based in large part on the 2014 legislation,

**NOW, THEREFORE, BE IT RESOLVED**, That the Providence City Council hereby declares its support for the passage of House Bill 2015 H-5819 and Senate Bill 2015 S-0269 and urges the General Assembly to vote in favor of its passage.

Resolution Endorsing and Urging Passage by the General Assembly of House Bill 2015 H-5364 and Senate Bill 2015 S-0291, An Act Relating to Labor and Labor Relations - Minimum Wage - Gratuities.

**WHEREAS**, Under Rhode Island law, employers may pay employees who receive gratuities, such as wait staff and bartenders, a sub-minimum wage of only \$2.89 per hour, less than one-third of the minimum wage for all other employees; and

**WHEREAS**, While the state and national minimum wages have been increased periodically in recent decades, the federal government has not increased the sub-minimum wage for employees receiving tips since 1991 and Rhode Island has not increased it since 1996; and

**WHEREAS**, Rhode Island has the lowest sub-minimum wage in New England; and

**WHEREAS**, Seven states have eliminated their sub-minimum wages, mandating that all employees, tipped or not, be paid at least the state's minimum wage; and

**WHEREAS**, According to the Economic Policy Institute, women make up the vast majority of tipped workers, at 72.9%; and

**WHEREAS**, Since workers living off tips rely on customers for their income rather than their employer, they must often tolerate inappropriate behavior from customer or risk loss of income; and

**WHEREAS**, A 2011 review of Equal Employment Opportunity Commission (EEOC) data revealed that almost 37% of all EEOC charges by women regarding sexual harassment came from the restaurant industry, even though less than 7% of employed women work in the restaurant industry; and

**WHEREAS**, A survey conducted by the Restaurant Opportunity Centers United and Forward Together found that female restaurant workers earning the federal sub-minimum wage are twice as likely to experience sexual harassment as women in states that pay the same minimum wage to all workers; and

**WHEREAS**, According to a report from the Economic Policy Institute, a tipped worker is more than twice as likely to live in poverty than workers on the whole and the poverty rate for wait staff in states with low sub-minimum wages is 19.4%, compared to just 13.6% in states without a sub-minimum wage; and

**WHEREAS**, If adopted, House Bill 5364 and Senate Bill 291 would gradually and incrementally increase Rhode Island's sub-minimum wage until it is equal to the State's minimum wage.

**NOW, THEREFORE, BE IT RESOLVED**, That the City Council of the City of Providence does hereby urge the General Assembly to pass H5364 and S291.


