AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1976-9, APPROVED APRIL 13, 1976, BY APPROPRIATING THE SUM OF EIGHTEEN HUNDRED (\$1800.00) DOLLARS FOR THE GREATER PROVIDENCE BABE RUTH LEAGUE, INC.

Approved September 9, 1976

Be it ordained by the City of Providence:

SECTION 1. Chapter 1976-9 of the Ordinances of the City of Providence as approved April 13, 1976, entitled: "An Ordinance Making Appropriation of \$94,528,529.66 for the Support of the Government for the Fiscal Year July 1, 1975 and ending June 30, 1976" is hereby further amended by appropriating the sum of Eighteen Hundred (\$1800.00) Dollars to the Greater Providence Babe Ruth League, Inc., a non-profit organization which has been awarded the honor of Hosting the 1976 New England 13-Year-Old Baseball Tournament from August 12, 1976 through August 15, 1976, inclusive, at McCoy Stadium, Pawtucket, Rhode Island; that the Tournament will consist of eight teams, Providence being the Host team is automatically in the Tournament along with one other Rhode Island team, two teams from Massachusetts, and one team from Connecticut, Vermont, New Hampshire, and Maine; that the out-of-town team players, consisting of a total of ninety players, will be housed with various families throughout the City known as "Family Hosts." The Tournament Headquarters will be located at the Holiday Inn, Providence, Rhode Island, and many activities are being planned for the visiting teams to make their visit to the City a most enjoyable and memorable one. As the said League is a non-profit organization, it does not have the resources to fund the expenses incurred in this program, viz:
