ORDINANCES SECOND READING

The following Ordinances were in City Council February 20, 1997, Read and Passed the First Time and are Returned for Passage the Second Time:

An Ordinance Increasing from Two Thousand Dollars (\$2,000.00) to Five Thousand Dollars (\$5,000.00) the amount for Contracts of Purchase pursuant to the provisions of the Providence Home Rule Charter Section 1007 (c) (1).

Be it ordained by the City of Providence:

Section 1.

Whereas, Section 1007(c)(1) of the Providence Home Rule Charter of 1980 provides:

(c) It shall be the responsibility of the board of contract and supply:

(1) To make all contracts for purchase of

materials, supplies, services, equipment and property on behalf of the city, the price or consideration of which shall exceed two thousand dollars (\$2,000.00), on the basis of sealed bids solicited through public advertisement in a newspaper of general circulation in Providence, such bids to be submitted, opened and considered in accordance with rules and regulations approved by the board. The city council may increase the figure of two thousand dollars (\$2,000.00) by a two-thirds vote following a public hearing, but no more often than once every five (5) years, and

Whereas, Section 1006(c) of the Providence Home Rule Charter of 1980 provides:

(c) [Purchases of less than two thousand dollars.] All contracts for purchase of materials, supplies, services, equipment and property on behalf of the city, the price or consideration of which shall exceed five hundred dollars (\$500.00) but amount to less than two thousand dollars (\$2,000.00) shall be made by the director of public property on the basis of three (3) or more informal competitive bids, which may be solicited without advertising, but which must be submitted in writing. Upon receipt of said informal bids and such contract shall be awarded to the lowest responsible bidder among them. All purchases made on behalf of the city, the price or consideration of which shall be five hundred dollars (\$500.00) or less, shall be made by the department or agency requiring the materials, supplies, services, equipment or property involved, in accordance with rules and regulations established by the director of public property. No purchase request which is essentially a unit shall be divided for the purpose of evading the requirement of solicitation of competitive bids set forth in this subsection or that set forth in section 1007(c), clause (1) below; provided, however, that said requirements for competitive bidding may be dispensed with to allow emergency purchases upon the recommendation of the director of public property with the approval of a majority of all members of the board of contract and supply. Emergency shall be defined for the purposes of this subsection as an unforeseen situation, requiring immediate attention in order to safeguard the welfare of the people of the city, and one which renders the process of competitive bidding impractical or impossible; and

Whereas, R.I.G.L. Section 45-55-9 provides:

45-55-9. *Small purchases.* — Procurements not to exceed an aggregate amount of ten thousand dollars (\$10,000) for construction and five thousand dollars (\$5,000) for all other purchases may be made in accordance with small purchase regulations promulgated by the municipality. These amounts shall be increased or decreased annually hereafter at the same rate as the Boston Regional Consumer Price Index. Procurement

requirements shall not be artificially divided so as to constitute a small purchase under this section. A municipality may further reduce the aggregate purchase amount, as provided for in this section by ordinance; and

Whereas, The City Council, pursuant to Section 1007(c) of the Providence Home Rule Charter of 1980, may increase the figure of two thousand dollars (\$2,000.00) by a two-thirds vote following a public hearing, but no more than once every five (5) years; and

Whereas, Said figure of two thousand dollars (\$2,000.00) has not been increased by the City Council since the effective date of this Charter on January 3, 1983; and

Whereas, Consequently, more than five (5) years have passed since the figure of two thousand dollars (\$2,000.00) was established in January, 1983, and

Whereas, R.I.G.L. Section 45-55-9 permits small purchases in an amount not to exceed five thousand dollars (\$5,000.00) to be made in accordance with regulations promulgated by the municipality.

Section 2. Pursuant to Section 1007(c)(1) of the Providence Home Rule Charter of 1980, the City Council hereby increases the figure from two thousand dollars (\$2,000) to five thousand dollars (\$5,000) as the price or consideration for which all contracts to purchase materials, supplies, services, equipment and property are to be made by the Board of Contract and Supply.

Section 3. As a consequence of the operation of the provisions of Section 1 of this Ordinance, logic dictates that Section 1006(c) of the Providence Home Rule Charter which provides for "purchase of material, supplies, services, equipment and property, the price or consideration of which shall exceed five hundred dollars (\$500.00) but amount to less than two thousand dollars (\$2,000.00)" shall hereafter be interpreted and construed as applying to purchases wherein the

price or consideration of which shall exceed five hundred dollars (\$500.00) but amount to less than five thousand dollars (\$5,000.00).

Section 4. Upon passage of this Ordinance the City Clerk shall append an official copy of said Ordinance to the Providence Home Rule Charter of 1980 and provide for its publication as appendix to said Charter.

Section 5. This Ordinance shall become effective upon passage by a two-thirds vote of the City Council.

Section 103 A) — Official Zoning Map — Providence Zoning District Map 101, dated October 21, 1991 and amended June 27, 1994, shall be further amended as follows:

Change from R-2, Residential Two-Family District to M-1 Industrial District: Lots 280, and 281 on Zoning District Map 101 (also known as 150 Carolina Avenue).

Section 2. This Ordinance shall take effect upon passage.

An Ordinance in Amendment of Chapter 564 of the Ordinances of the City of Providence entitled: "The City of Providence Zoning Ordinance" approved June 27, 1994 and amended May 26, 1995 by amending Providence Zoning District Map Number 43 of the Official Zoning Map by changing the Zoning District Designation of Lots 385 and 386 from R-3 to C-2.

PERSONAL EXPRESSION

COUNCILWOMAN DIRUZZO requests the privilege of the floor to speak on a Point of Personal Expression:

"Before we read the Resolution with regard to the late Retired Fire Chief, Michael Moise, I stand on behalf of him.

Michael was a very dear friend of mine. We have lost a great man in the City of Providence, not only a great Fire Chief, out of respect to the subsequent people who followed him, one being the Deputy City Solicitor's father, I have to say that Fire Chief, Michael Moise was probably the best Fire Chief that we have ever had here in the City of Providence. I know he was one of the greatest men that I have ever known, next to my father.

Michael served on the Providence Fire Department for a period of approximately 40 years and he was Chief of the Fire Department for seventeen years. He was the youngest Chief to be appointed to the Providence Fire Department. He loved the City of Providence and he served his Country as well in the United States Marine Corps. When he retired, he retired at the rank of Major, a highly decorated Marine. He retired in 1990. He didn't have much of a chance to enjoy his retirement. He spent every living moment in his office. I spent a lot of time there. He taught me a lot about Firefighting during our friendship. He gave up a lot of time with his family to serve this City and to serve the people in this City. He loved his job and he loved people. He was the most humble man I have ever met. He was the most religious and kind and gentle man I have ever met and I know, that I will never meet another man like him.

He leaves eight children and I was amazed at the way they handled today and the last few days. He died Saturday after fighting Melanoma Cancer for 4½ years. With all the fires that he fought, he couldn't fight this disease. So, Saturday at ten minutes after 12, ten minutes afternoon time, he expired and he died with dignity even with all the suffering he went through. I visited him at the hospital a week before his death and even with that he tried to carry on a conversation. He was full of love for everybody and he gave his life for people.

I want to thank the Mayor and the Providence Fire Department for the expression of love and respect that they showed to Michael today. I was proud of this Fire Department, I was proud of the Providence Police Department today, the Traffic Division and I need to talk to the Fire Chief and I need to talk to the Police Chief as well. The Traffic Division did an outstanding job today. They directed a funeral procession from Saint Paul's Church on Broad Street through to downtown so that Michael could come by his favorite place in LaSalle Square for one last time and when we approached the Station, it was a scene to behold. The ladder truck were out in the Street, crisscrossed and all the Firemen saluted their retired Fire Chief. For that, I am grateful and I know the family was very grateful. It was magnificently done by the Fire Department and magnificently done by the Police Department. I want to thank you Mayor, for all of your help.

I would like to ask for a 'Moment of Silence' in Memory of this wonderful person, Retired Fire Chief, Michael F. Moise."

Minute

Providence Fire Chief Michael F. Moise, was born in Providence, a son of the late Frank M. and Lillian Simonetti Moise.

After graduating from LaSalle Academy, Class of 1947, he enlisted in the Marine Corps, and after a year of service qualified for the officer training program and enrolled at Providence College, where he graduated in 1952.

Upon college, he served two years of active duty at Camp Lejune and Cherry Point in North Carolina and with detachments in Puerto Rico and at Quantanamo Bay in Cuba.

In 1954, he became a Providence Fireman, where he rose through the ranks and was appointed Chief in 1973 at the age of 43, becoming

the youngest person in the department's history to hold that position.

During his tenure as Chief, he ran the department well and was at every major fire in the city from 1961 until he retired in 1990 with an impeccable record second to none.

In 1971, he was given a leave of absence from the department to serve as an administrative assistant to then Mayor Joseph A. Doorley, Jr.

Upon his retirement he wintered in Florida.

A devout father, he helped raise four sons Michael F. Moise, Jr., Thomas J. Moise, John P. Moise and Stephen J. Moise; four daughters, Kathleen, Maureen A. Conlin, Marcia Wall and Mary E. Moise; two brothers, William J. Moise and Frank J. Moise and thirteen grandchildren.

With his passing, Michael F. Moise will be missed and mourned by his legion of friends and associates to whom he has bequeathed a wealth of fond and wonderful memories and may God, in his wisdom, bestow upon Michael F. Moise, Eternal Rest and to his family, peace and tranquility.
