Dear Mayor Smiley:

The Providence Fire Department respectfully requests approval to pay Brindlee Mountain Fire Apparatus for two 2016 Pierce Impel Pumpers, VIN#4P1BAAFF3GAD16518 and VIN#4P1BAAFF1GA016520 at the price of \$275,000 per vehicle in a total amount not to exceed \$550,000 in Fiscal Year 2023.

During recent inspections by the Fire Maintenance Garage, it was noted that two (2) of the department's frontline pumper trucks are exhibiting significant corrosion impacting the condition of the vehicle frame. These two pumper trucks are a 23-year-old Pierce pumper assigned to Engine 8 at the Messer Street Fire Station and a 21-year-old Pierce pumper assigned to Engine 2 at the Branch Avenue Fire Station. Due to the critical need to replace these vehicles and the estimated twenty-four months for delivery of a new vehicle—Fire Maintenance Superintendent George Lazzareschi has researched and identified two (2) 2016 Pierce Impel pumpers available for sale from Brindlee Mountain Fire Apparatus in Union Grove, AL. The vehicles are in impeccable condition and have significantly less use, hours, and miles than the current two.
