Within ten (10) days of service of this notice of violation and upon written request to the Division of Code Enforcement, wherein is set forth: (1) a brief statement of the grounds therefor; (2) the person and address upon whom notices and orders may be served and; (3) why such enforcement or compliance should not be effected, a hearing will be granted to you before the Director or his designate.
