Be it ordained by the City of Providence:

SECTION 1. Chapter 1288 of the Ordinances of the City of Providence as approved September 18, 1959 entitled: "An Ordinance Making Appropriation of \$39,301,585.32 for the Support of the City Government for the Fiscal Year Ending September 30, 1960", as amended, is hereby further amended by appropriating the sum of Thirty-Two Thousand (\$32,000) Dollars to PUBLIC WORKS DEPARTMENT-SEWAGE DISPOSAL SECTION, ITEM 1.

SECTION 2. The said sum of Thirty-Two Thousand (\$32,000) Dollars as thus added and appropriated shall be obtained by increasing the estimated receipts from, PROPERTY TAXES-PREVIOUS YEAR by the sum of Thirty-Two Thousand (\$32,000) Dollars.

SECTION 3. This Ordinance shall take effect upon its passage.

RESOLUTION OF THE CITY COUNCIL

No. 401

Approved September 2, 1960

Resolved,

That in accordance with the provisions of Section 28 of Chapter 1665 of the Public Laws of 1945, approved April 27, 1945, the City Controller is hereby authorized and directed to establish in the accounts for the year ending September 30, 1961, a specific purpose account to be known as "Reserve for Revenue for Extraordinary Expenditures of the Year 1960-1961". Said account shall be established by charging to the account entitled "Current Year Surplus" of the accounts of 1959-60, an amount equal to any credit balance existing in said Current Year Surplus Account at the close of the fiscal year. After completion of the above transfer, the account entitled "Reserve for Revenue for Extraordinary Expenditures of the year 1960-61" shall be carried over to the books of account for the year 1960-1961 with an open credit balance equal to the amount of the transfer.

From time to time during the year ending September 30, 1961, the City Council, when necessary, may direct the City Controller and the City Treasurer to pay out of General Fund cash the total or any part of the then credit balance existing in the account entitled "Reserve for Revenue for Extraordinary Expenditures of the year 1960-1961", each such payment shall be charged to said account and shall immediately be paid over to the City Collector as a receipt account, and when so received by him, shall be credited to a receipt account to be entitled "Receipts for Extraordinary Expenditures of the Year 1960-1961". The City Controller and the City Treasurer are hereby authorized and directed to pay out of General Fund Cash, the total of any balance remaining in the "Reserve for Revenue for Extraordinary Expenditures of the Year 1959-1960" and such payment shall be charged to said account and paid over to the City Collector as a receipt to "Receipts for Extraordinary Expenditures of the Year 1959-1960". The estimated "Receipts for Extraordinary Expenditures of the Year 1959-1960" are hereby increased by an amount that will make such estimate equal to the actual "Receipts for Extraordinary Expenditures of the Year 1959-1960".

Dear Sir:

This lot is 160 feet long, 32 feet wide, and
abuts a platted street 20 feet in width, which connects
Burns and Lubec streets.

Burns and Lubec streets are parallel, 160 feet
apart, extending from Douglas avenue to Admiral street,
and are connected by Douglas avenue, Havana, Manila and
Admiral streets, all of which are paved.

In my opinion, an additional connecting street
is unnecessary, and the acquisition of land for this
purpose could not be justified.
