## CHAPTER 1976-39

No. 618 AN ORDINANCE IMPLEMENTING THE PROVISION OF 76-H 7601 MAKING TWO AND THREE FAMILY DWELLINGS ELIGIBLE FOR THE HOMESTEAD PROGRAM AND ALLOWING THE HOMESTEAD BOARD TO ACCEPT PROPERTY DONATED TO THE CITY FOR REHABILITATION.

Approved December 9, 1976

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1975-12, approved May 8, 1975, entitled, "An Ordinance Implementing the Provisions of Chapter 256 of the Public Laws of 1974, Authorizing the City of Providence to regulate a "Homestead Program" is hereby amended as follows:

SECTION 1. (d). lives in, <sup>OCCUPIES</sup>~~occupies~~ and maintains as a single two or three family dwelling to city or town housing standards, the parcel assigned to him for a period of not less than three (3) years. 2.2.

SECTION 2. The Homestead Board of the City of Providence is hereby authorized to accept any real property donated to the City of Providence without restrictions as the Homestead Board deems qualified to fulfill the purposes of the Homestead Program and all properties so donated to the City shall be utilized for the purposes of the Homestead Program, prior to any other disposition of the same.

SECTION 3. This Ordinance shall take effect upon its passage.
