*Whereas*, One Hundred Thousand (100,000) people in Rhode Island and over 15 Million (15,000,000) people across the U.S. suffer from unemployment and underemployment — double the “official” governmental figures which do not count the long-term unemployed, youth and those receiving public assistance who want to work, and

*Whereas*, Over 45,000 manufacturing jobs have been eliminated in Rhode Island since 1984 and over 5 Million jobs have been eliminated by Fortune 500 Corporations and other businesses in the past 15 years, and

*Whereas*, Most private-sector job creation has been low-wage and/or temporary or part-time employment, with few if any benefits and no job security, and

*Whereas*, The minimum wage has lost one quarter of its value since 1969 and one in five full-time workers earn wages that put their families below the poverty line, including close to 50,000 Rhode Islanders, with fully one half of all young workers earning poverty level wages for a National total of 37 Million people living in poverty — the highest level since 1962, and

*Whereas*, Nationally, only 32% of jobless workers are getting regular Unemployment Insurance Benefits and those who received benefits received, on average, only 37% of their previous weekly wages, and

*Whereas*, Unemployment is running at twice the overall rate for people of color and three times the overall rate for youth, and

*Whereas*, Chronic, widespread joblessness and low wages are the main underlying causes of poverty, homelessness, street crime, substance abuse, spousal and child abuse and social decay in general,

*Now, Therefore, Be it Resolved*, That the Providence City Council hereby calls upon Congress and the President of the United States

of America to take the following action to deal with the above mentioned crises:

1. Enact a **massive public jobs program** offering employment to all who seek work rebuilding our Inner Cities and National Infrastructure and in providing needed Social Services.

2. **Double the Minimum Wage** so that no worker will live in poverty.

3. **Extend Unemployment Benefits** indefinitely to all jobless at a livable level until there is work for them.

## REPORTS FROM COMMITTEES

### COUNCILMAN ROBERT M. CLARKIN, Chairman COMMITTEE ON PUBLIC WORKS

Transmits the following with Recommendation the Same be Severally Approved:

Resolution Authorizing and Affirming an Application to Coastal Resource Management.

*Whereas*, New England Power Company, the parent company of Narragansett Electric Company, is conducting an extensive refurbishment of the Manchester Street Power Station; and

*Whereas*, in the course of that renovation, New England Power Company has determined that the South Street Station is no longer suitable for its needs; and

*Whereas*, both the Manchester Street and South Street Stations are serviced by a cool-water channel which extends from the former to the Providence Hurricane Barrier; and

*Whereas*, the section of the cool-water channel from the Manchester Street Station to the Providence Hurricane Barrier is no longer needed; and

*Whereas*, the proposed demolition of the same requires approval by the Rhode Island Department of Environmental Management and other governmental agencies; and

*Whereas*, in order to facilitate the demolition

process, said application had to have been filed in an expeditious manner,

*Now, Therefore, Be it Resolved*, That the application on behalf of the New England Power Company and the City of Providence executed, inter alia, by B. James Suzman, Director of the Department of Public Works, is hereby ratified and affirmed.

Resolution Requesting permission to construct and install an electronic bus passenger information system in Kennedy Plaza as requested by the Rhode Island Public Transit Authority.

*Whereas*, the Rhode Island Public Transit Authority seeks to construct an electronic bus passenger information system; and

*Whereas*, the constructor of said system requires entry into the street; and

*Whereas*, after review, it has been determined that such entry will require entry into the street and certain underground conduits; and

Whereas, said information system is in the public interest,

Now, Therefore, Be it Resolved, That the Rhode Island Public Transit Authority is hereby authorized to make certain street opening cuts in the Kennedy Plaza area as indicated on the attached map marked Exhibit "A." Said street opening cuts shall be made in conformity with all Department of Public Works' recommendations and repair of the location shall be to present standards.

1. The grant contained herein is terminable by the City of Providence at will provided that notice of removal shall be forwarded to the Rhode Island Public Transit Authority, care of its Director of Marketing and Planning not fewer than thirty (30) days prior to the date from which removal is to be made. The grantee, by undertaking any construction pursuant to this resolution, expressly agrees to the aforementioned termination procedure.

2. During the course of any construction, the grantee shall maintain general public liability insurance in a sum not less than one hundred thousand dollars (\$100,000.00).

3. Additionally, the grantee shall indemnify and hold harmless the City of Providence, its agents, officers, servants and employees, from any and all claims or causes of action arising out of the installation, existence, maintenance and removal of the electronic bus passenger information system. The grantee shall execute such an agreement which shall be satisfactory to the City Solicitor.

4. The grantee shall undertake any construction authorized hereunder in a manner consistent with the existence of a current utility or other rights-of-way and shall provide any utility providers with appropriate notices and, if necessary, appropriate easements.

Resolution Requesting permission to extend 4 feet on the sidewalk of 568 South Main Street/40 Tockwotton Street, for the purpose of building a Handicapped Ramp at that location.

Whereas, Jazz Express (hereinafter "Petitioner") has sought to construct a handicap ramp at the entrance to 568 South Main Street/40 Tockwotton Street, Providence, Rhode Island; and

Whereas, said ramp as proposed will encroach upon the public walkway; and

Whereas, after study of the Petitioner's request, the City, acting through its appropriate authorities, has determined that the proposed encroachment is not adverse to the public interest,

Now, Therefore, Be it Resolved, That the Jazz Express is granted permission to construct and maintain a handicap ramp at the entrance to 568 South Main Street/40 Tockwotton Street, Providence, Rhode Island. Provided, however, that said grant is specifically conditioned upon:

1. All construction with relation to the said ramp is completed in accordance with plans and specifications submitted by the Petitioner to the City Department of Inspection and Standards as those plans may have been modified and/or approved by said Department and the Council Committee on Public Works.

2. The Petitioner shall supply and retain in effect a certificate of insurance in an amount of not less than one hundred thousand dollars (\$100,000.00) protecting the City of Providence and its assigns, successors, agents, employees and assigns as additional-named insureds against claims for the construction, maintenance and/or existence of said ramp. Said insurance shall be acceptable to the Department of Law.

3. The Petitioner shall execute an indemnification and hold harmless agreement satisfactory to the City Solicitor.

4. The Petitioner shall grant to the appropriate

public utility(ies) and/or governmental agency(ies), by pertinent document, any easements, licenses, or the like, so as to maintain public services.

5. A certified copy of the within Resolution shall be recorded in the Office of Land Evidence of the City of Providence.

6. Any rights or obligations granted hereunder shall be deemed to run with the land and shall operate against any and all successors in interest and/or title.

7. Any rights or obligations granted hereunder shall remain in full force and effect for so long as the encroachment permitted hereby does cease to be utilized for the purposes specified earlier.

8. Such other reasonable conditions as the Mayor and/or the Department of Law may impose hereunder.
